I am writing you to lend my support to my dear friend Vickie Roberts whose son Maurice Dillard was killed in a tragic accident on, March 3, 2020 while riding his motorcycle on Monterey Road and Valleyhaven Way.

I reside on Branham Lane and have called this particular San Jose neighborhood my home for 25 years. It would be impossible to count the number of times that I have traveled down Monterey Road near Valleyhaven Way. Since March 3, I can't bear to make that journey because that stretch of road has a different meaning for my family now. Dear Mayor Sam Liccardo,

My name is Ms. Vickie Roberts and I and raised right here in San Jose resident in addition I am the mother of Maurice Alexander Dillard.

My son, Maurice was 28 years old and tragically killed in a horrific accident at Monterey Road and Valleyhaven Way Tuesday, March 3rd of this year. I will never forget, it was Super Tuesday, we turned our voting ballots in at the Edenvale library that morning.

Maurice was riding his motorcycle northbound and was struck by a car turning from southbound Monterey Road onto eastbound Valleyhaven Way. Maurice was hit with such force that he flew off his bike into the barrier wall and onto the front yard of the corner house on Valleyhaven Way. His right arm was completely dismembered and his left leg and left side of his torso were partial detached. My son, Maurice Dillard was pronounced dead at the scene. He was less than 1.5 miles away from our home.

This accident would have been prevented if there was a traffic light to make the left hand turn off of Monterey Road and onto Valleyhaven Way, safely. My son Maurice would still be alive today and we would've celebrated my birthday on April 8th, his 29th birthday on April 20th, his only nephews (my grandson) 1st birthday on April 21st and Mother's Day. I am not sure where he was headed that evening before coming home, but I know that he would have made it home, had the driver of car that hit him would have went up to the light on Branham Lane, rather than taking a shortcut through the Havens Neighborhood.

I previously submitted letters from supporters to my Council member Mr. Sergio Jimenez to assist in having a traffic light installed at the intersection of Monterey Road and Valleyhaven for traffic safety. My hope in having a traffic light installed is to help prevent another accident or tragic death on our city streets. I never want to hear about another mother or family experiencing and having to live with the pain that I myself, our family and friends have to live with now and everyday for rest of our lives.

A formal proposal has been submitted to you for review from Mr. Jimenez. Attached you will find the copies of the documents for your convenience and reference.

With the continued support of my family, friends, Valleyhaven neighbors, San Jose residents and community, I ask you to please sincerely consider supporting, funding and approving this project.

This project will be my continued mission to see completed with the help and assistance of my many more supporters and I hope, you as well Mayor Liccardo.

I look forward to your much anticipated response and also look forward to working together to make our city streets safer for all.

My name is Debbie Hernandez, a former resident of the Seven Trees area in San Jose. Born and raised there and an Andrew Hill Alumni Class of 1977. Go Falcons! Not only was I raised there, I also owned a home and raised my own 3 children in my hometown. I currently have family members who live in the Seven Trees and Area off of Monterey Road near Valleyhaven.

I am writing in support of a request to install a stop light on the corner of Monterey Road/Valleyhaven Way. The traffic on Monterey Road travel can travel up to 60 mph or more even though the speed limit is 55 mph. This intercession is a death trap without a traffic street light there. On Tuesday, March 3, 2020, this deadly intercession took the life of a young man by the name of Maurice Alexander Dillard as he was riding his motorcycle down Monterey Road and was stuck by a vehicle making a turn crossing Monterey Road on to Valleyhaven Way. Maurice was struck at such a strong force it throw him from his motorcycle into the barrier wall and onto the front yard of the corner house on Valleyhaven Way. His body was dismembered and he was pronounced dead at the scene.

This accident could have been prevented had there been a Traffic Stop Light at that intercession. As I mentioned, being a former resident and individual with several family members the area near this intercession. I strongly petition that a Traffic Stop Light be placed at this intercession to prevent the lose of lives who could suffer the same tragedy as Maurice Dillard. The residents living in the area of Monterey Road and Valleyhaven should not have to mourn the lose of a loved one simply because the city did not think there was a need to add a Traffic Stop Light at this intercession.

I sincerely hope and pray that this will be taken into great consideration. Lives are depending on it.

Please do the right thing to save lives.

My name is Yuriko Manibusan, a former resident from district 4 in San Jose, Ca. I'm writing you today to inform you that I stand behind Ms. Vickie Roberts on placing a stoplight on Monterey rd and Valleyhaven. As you know, on March 3rd, 2020 we lost someone so dear to us. Maurice Dillard was not only a great son, but a great citizen of San Jose. He touched so many hearts and was well known in our city. Unfortunately we lost him due to a driver with poor judgment and lack of awareness because Monterey rd is left as a free for all. Especially that intersection.

Some drivers operate as if they always have the right of way. However, all drivers have a duty to obey the rules of the road in order to avoid foreseeable harm to others. This could have been avoided if there was some sort of traffic light/sign. Failure to yield the right of way when required by law can lead to liability for any resulting accidents. And because there isn't anything that forces drivers to obey the fundamentals of traffic laws and driving behind the wheel, then expect more accidents to happen on Monterey rd. How many more lives do we have to lose before there is change?

The tragedy suffered by Maurice's Mother, family, and friends can never be justified; she will always have to live with the loss of her beloved son. It is important however, that justice be served, that a message be sent to all drivers that reckless negligence will not be tolerated and a stoplight will be placed to prevent future accidents and deaths.

Having family with careers in law enforcement I was recently educated that a stop sign may be warranted at an intersection where one of more of the following conditions exist:
intersection of a less important road with a main road where application of the regular right of way rule is hazardous ; street entering a through highway or street; Unsignalized intersection is a signalized area; other intersections where a combination of high speed, restricted view, and serious accidents recorded.

The location where my dear friend took his last breath clearly fits the description. I understand stop signs are not always the answer, but I can rest assure that a stop light can help ease the people of San Jose and prevent further tragedies. We are tired of losing love ones to something that can be easily fixed with your understanding and approval.

This devastating emotional loss associated with the grief and mental anguish that Vickie Roberts has to endure over the death of her son will never be forgotten. But if granted this stop light I'm sure that it will bring tears of joy and victory that mothers and fathers will never get that call that Vickie did on that tragic day.

Thank you for taking the time on reading my message. I hope you find it in your heart and mind that this is a serious matter that needs to be addressed as soon as possible.

This is for you Maurice. I love you and I pray for change.

Dear City Clerk of San Jose,

Hello my name is Stephanie Scelzi and I am a Community Service Officer (Class 1 hired in 2014) for the city of San Jose. I was also dating Maurice Dillard who was tragically killed in a motorcycle and vehicle accident that occurred on March 3, 2020 at the intersection of Monterey Road and Valleyhaven Way.

I have worked the Southern District for approximately five years and I am very familiar with that area. Maurice's accident at that intersection was not the first (I believe the corner resident had recently had the cement barrier wall fixed from a prior accident and it was damaged again due to the force from the accident from Maurice's body) and I don't think it will be the last if a traffic light is not installed there. I have seen numerous of other accidents (non-injury, minor injury, non reported/exchange of information) at or close proximity around that intersection. Monterey Road is a high traffic road, that quite frankly, I believe needs more stop signs or traffic lights. The straight way road makes it easy for people to speed.

I have seen many accidents in the line of work I am in and I have seen the trauma that these family members are in when they show up to the scene of the accident. When the confirmation came that it was in fact Maurice involved in the accident, I was now in their shoes, on the other side of the accident, and experiencing the pain as it effected me personally. To make matters worse, I was at work that night and heard the call come in. Anytime there was an accident in the area, an area in which he and his family lived, I checked on him to make sure he was okay but that night unfortunately had a tragic outcome.

It appeared that the driver of the vehicle was taking a shortcut home by turning eastbound onto Valleyhaven Way after traveling southbound Monterey Road instead of going up to Branham Lane to access the traffic light in a safely manner. Had there been a traffic light at the intersection for the driver of the vehicle to utilize, I strongly and firmly believe that this accident would have been prevented and Maurice would still be here. To know Maurice was to love Maurice and the impact he made on everyone's life that he came across was made undeniably evident in his sudden tragic passing.

I understand installing a traffic light will not bring him back but my hopes are that a traffic light will help lessen the likelihood of another fatal accident occurring there and prevent other family and friends experiencing a sudden tragic loss of a loved one. Please take into consideration the funding and installation of a traffic light at the intersection of Valleyhaven Way and Monterey Road for the safety of the residents of San Jose.

My name is Jennifer McQueen. I have been living in San Jose my whole life (28 years.) I am a good friend of Maurice Dillard. He was tragically killed on Monterey Road and Valleyhaven Way in South San Jose on March 3rd 2020. He was riding his motorcycle home that night around 6:30pm when a driver hit him going eastbound onto Valleyhaven Way. The impact was so hard that his right arm was completely severed and his left arm and torso were partially severed. He flew over a brick wall onto a neighbors front yard. He died instantly at the scene.

He was a positive person that everyone wanted to be around. I miss my friend everyday, wishing he was still alive. He was so loved by his family and he had many friends that miss him dearly. He had an impact on the community working with autistic children. He would have loved to live a long life of sharing and giving to his community.

Visting the site after his passing, I have noticed how dangerous the intersection is. Cars are going really fast (faster then the speed limit) both ways on Monterey Road. I have seen a few cars almost get into accidents with other drivers even motorcycles while I'm visiting. I feel it is important to put a traffic signal there to help avoid accidents like Maurice's.

Please consider putting a traffic signal at Monterey Road and Valleyhaven Way to help protect the community and to make San Jose a safer place.

I met Vickie over ten years ago at The Jungle Island when I was a Supervisor there. Her and her children would often come in to play games and hang out. I am a person who loves to be around family, so I admired how close their she and her kids were. She quickly became a good friend of mine, which lead to me getting her daughter a job at The Jungle Island and her family attending my child's baby shower and birthday parties over the years, as while as me attending her family functions.

With the friendship that we developed, you could imagine how heavy my heart felt when I found out her son, Maurice, had been killed. I just kept saying to myself, "No, No, No," as I wept for Vickie. She has a bound with her children that no one could understand and I knew for a fact that she would never be the same again. Not only did I imagine her pain but I put myself in her position. I often drive down Monterey Road with my children and that could have easily been my family hit and killed because someone failed to yield to on coming traffic. To my knowledge people often turn left into this neighborhood, which says to me, that this tragedy will happen again.

After the passing of Maurice so many people came out to support his family. He was truly loved and respected by everyone he came in contact with. I also learned after his death that he was a advocate for children with autism and worked with autistic children for the past 10 years. A task that is very difficult to do and that most young men would not sign up for. To me that shows his character and further emphasizes that we lost him too soon!

We are asking for a traffic light to be installed at the corner of Monterey Road and Valleyhaven Way in honor of Maurice Dillard. Please do not let his death be in vain. Please help protect the residents and visitors of San Jose who travel down this street on a daily bases.

Maurice's life was suddenly and tragically taken from us early March of this year, as Ms. Vickie Roberts stated below in detail.

The loss of Maurice has impacted so many of us. He was more than just a friend, son, uncle, nephew, he was an inspiration. He helped any and everyone in need. He was an activist for all humans, especially ones that are on the autism spectrum, that was his passion. He was the one to always remind us to "Live In the Moment" and truly enjoy life! I know there's nothing that anyone can do to bring him back, but there is something that you can do, so this tragedy doesn't happen to anyone else. So no one else has to feel the pain and hurt that so many of us are feeling and will continue to feel.

Our plan of action is to ask for your help in funding to put a stop light at Monterey Road and Valleyhaven Road. At this particular "intersection", drivers are constantly darting out to make the turn onto both Monterey and Valleyhaven roads. Some drivers live in that area or, others use the Havens area to miss the light at Branham lane. Drivers going south on monterey road would much rather cut through the havens to get to East Branham lane, than to wait at the light to get there! And not only would they rather not wait at the light, but they're speeding and barely slowing down to make the turn onto Valleyhaven Road from Monterey road!

Again, that particular stretch of Monterey Road, people are speeding by! To keep up with traffic, from personal experience, drivers are going a good 55-60 MPH; it's a 45 MPH zone!! There's been plenty of occasions where I've witnessed drivers almost get into accidents. So, not only would this stop light stop people from darting across Monterey road, but it'll also stop the speeding problem. I've seen the posters on monterey road that states "Speed kills, slow down." Instead of expecting DRIVERS to read WHILE DRIVING, put the light there. My name is Brandilyn Young. I was raised here in San Jose & I am a current resident of San Jose. In addition, I am a friend of Ms. Vickie Roberts who is the mother of Maurice Alexander Dillard. Vickie was raised in San Jose & still lives here as well. Her son Maurice was a resident of San Jose until his life was needlessly taken.

Vickie's son, Maurice was 28 years old and tragically killed in a horrific accident at Monterey Road and Valleyhaven Way on Tuesday, March 3, 2020.

Maurice was riding his motorcycle northbound and was struck by a car turning from southbound Monterey Road onto eastbound Valleyhaven Way. Maurice was hit with such force that he flew off of his bike into the barrier wall and onto the front yard of the corner house on Valleyhaven Way. His right arm was completely dismembered and his left leg and left side of his torso were partial detached. Vickie's son, Maurice Dillard was pronounced dead at the scene. He was less than 1.5 miles away from home.

This accident would have been prevented if there was a traffic light to make the left hand turn off of Monterey Road and onto Valleyhaven Way, safely. Maurice would still be alive today and he would have celebrated his Mother's birthday on April 8th, his own 29th birthday on April 20th, his only nephew's (Vickie's grandson) 1st birthday on April 21st and Mother's Day. I am not sure where he was headed that evening before coming home, but I know that he would have made it home, if the driver of car that hit him would have gone up to the light on Branham Lane, rather than taking a shortcut through the Havens Neighborhood.

Vickie previously submitted letters from supporters to my Council member Mr. Sergio Jimenez to assist in having a traffic light installed at the intersection of Monterey Road and Valleyhaven for traffic safety. My hope in having a traffic light installed is to help prevent another accident or tragic death on our city streets. I never want to hear about another mother or family experiencing and having to live with the pain that Vickie, her family, friends & Maurice's loved ones have to live with now and everyday for rest of their lives.

I am writing about a serious problem regarding the apparent danger of the left turn onto Valleyhaven Way from southbound Monterey Road in San Jose.

Valleyhaven Way leads to neighborhoods and heads directly towards Danna Rock Park. If traveling southbound on Monterey Road, one must make the left turn across three lanes of traffic, in addition to a bike/turning lane, to make it past this busy road. People often use poor judgment with the amount of time required to turn safely. Also, there is a wide center divider with trees that causes people to prematurely turn their wheels in anticipation, which could be dangerous if they get rear-ended into oncoming traffic.

I recently lost a loved one, Maurice Dillard, to another motorist who was making this left turn. It is only a matter of time before there is another serious, if not fatal, accident here.

Therefore, I would like you to seriously consider adding a traffic light that includes left turn signaling onto Valleyhaven Way from Monterey Road to increase traffic safety.

My name is Cherisa Dillard,

My step son, Maurice was 28 years old and tragically killed in a horrific accident at Monterey Road and Valleyhaven Way Tuesday, March 3rd of this year.

Maurice was riding his motorcycle northbound and was struck by a car turning from southbound Monterey Road onto eastbound Valleyhaven Way. Maurice was hit with such force that he flew off his bike into the barrier wall and onto the front yard of the corner house on Valleyhaven Way. His right arm was completely dismembered and his left leg and left side of his torso were partial detached. My son, Maurice Dillard was pronounced dead at the scene. He was less than 1.5 miles away from our home.

This accident would have been prevented if there was a traffic light to make the left hand turn off of Monterey Road and onto Valleyhaven Way, safely. My son Maurice would still be alive today and we could have celebrated his 29th birthday on April 20th. I am not sure where he was headed that evening before going home, but I know that he would have made it home, had the driver of car that hit him would have went up to the light on Branham Lane, rather than taking a shortcut through the Havens Neighborhood.

Previously submitted letters from supporters to Council member Mr. Sergio Jimenez to assist in having a traffic light installed at the intersection of Monterey Road and Valleyhaven for traffic safety. My hope in having a traffic light installed is to help prevent another accident or tragic death on our city streets. I never want to hear about another mother or family experiencing and having to live with the pain that our family and friends have to live with now and everyday for rest of our lives.

My friend, Maurice Alexander Dillard, was a pillar in our community, he was a friend who was always ready to give the shirt off his back if you needed it. He worked with Autistic children, and made a difference in their lives, and ours. Maurice, also known as Mo, was kind, gentle, loving, and at the young age of 28 years old, was tragically struck. The car was speeding at an alarming rate, going Southbound on Monterey Road (Eastbound of Valleyhaven Way) that when he/she (driver) did not see our friend on his motorcycle - was hit with such force, that he was thrown off his motorcycle, from the street onto the corner house - brick wall (Please see the pictures below, where you see the top layer of the wall broken off, *User Discretion is advised) The impact was so strong that his right arm was completely dismembered, his left leg and left torso, were also partially detached.

As the Mayor, of this beautiful city, and the council member that help us feel safe within our communities, I sincerely ask of you, to please come together and provide the hope and security we seek as a community. We are asking to place a stop light at this unsafe intersection, so other families do not mourn their loved ones, based on speeding, negligent drivers. This stop light will force the driver to slow down, stop, and continue to drive on the STREETS, and not speed down, as a continued highway.

Were you aware that in the last decade, the number of walkers/pedestrians being struck by vehicles has risen 60% ? 35 % in Santa Clara County, ALONE, in the LAST YEAR. (2019)

Let us be the voice, and the change to continue to keep San Jose safe, for future families and drop our traffic fatalities down. Let's decrease statistics instead of continuing at an alarming rate.

A formal proposal has been submitted to Mayor, Mr. Sam Liccardo by our City Councilman in District 2, Mr. Sergio Jimenez.

Re: Safety Improvements Needed for Valleyhaven Way and Monterey Road/State Route 82

I am writing in regards to a dangerous left turn lane onto Valleyhaven Way from southbound Monterey Road. This has been the scene of many accidents over the years, the most recent on March 3, 2020 causing the tragic death of Maurice Dillard who was traveling northbound on Monterey Road when he was violently broadsided by a Jeep turning left onto Valleyhaven Way from southbound Monterey Road.

I am advocating for Vickie Roberts, Maurice's mother, to put a stop light there to make it safer for residents of the Valleyhaven neighborhood to access their homes and neighborhood. It is my belief and experience that many motorists use this turn as a shortcut, turning onto Valleyhaven Way to avoid having to wait to turn left at the traffic light at Branham Lane. It is my sincere belief that a traffic signal light there would discourage this behavior, providing a safer traffic option for citizens and avoiding tragedy.

I don't know why the driver didn't yield to Maurice on that fateful day, March 3, 2020. I don't know if she was distracted or trying to beat him, or avoiding the light at Branham Lane, or for some other reason. I am not a traffic engineer, but I am a concerned citizen and I believe that it is a bad design to have an unprotected left turn lane into a residential neighborhood, on a road such as Monterey Road (also State Route 82), which most often has a high volume of traffic, many travelling well in excess of 50 mph.

We do not want to read about any more fatalities there, and if it stays as it is now, there will be more. I also do not know the mechanics of how City government works and what coordination is needed with the State of California since Monterey Road is also a State Route, but I hope it starts with you. I have faith that we can make our streets safer. We owe Vickie Roberts that much at least, unquestionably.
