### **RECOMMENDATION**

Adopt a resolution authorizing the Director of Transportation to do the following:

- (a) Award and execute the 8547 OBAG2 (North) San Jose Pavement Maintenance Project, Federal Project No. STPL 5005(163), in a total amount not to exceed \$12,800,000 and establish a construction contingency of up to 5% of the contract amount, not to exceed \$640,000; and
- (b) Award and execute the 8549 OBAG2 (South) San Jose Pavement Maintenance Project, Federal Project No. STPL 5005(163), in a total amount not to exceed \$11,700,000 and establish a construction contingency of up to 5% of the contract amount, not to exceed \$585,000; and
- (c) Award and execute 9459 2020-2022 Local Streets Resurfacing Project (Multi-Year), in a total amount during the initial term not to exceed \$10,000,000, establish a construction contingency of up to 10% of the contract amount, not to exceed \$1,000,000, and do the following with regard to this contract:
  - (i) Exercise 2 separate options, with each option being for a period of one year for a total amount not to exceed \$10,000,000, contingent on the appropriation of sufficient funds; and
  - (ii) Establish a construction contingency for any option year of up to 10%, contingent on the appropriation of sufficient funds; and
- (d) As to each of the above construction contracts, decide any timely bid protest(s), make the City's final determination as to the lowest responsive bidder that is responsible, or reject all bids and rebid the projects.

#### **OUTCOME**

Approval of this resolution will enable the pavement construction contracts to be implemented with scheduled construction to begin in August 2020. The first two construction contracts will resurface 30 miles of streets on the Major Street Network. The third construction contract is a multi-year contract that will resurface 20 miles of streets on the Local and Neighborhood Street Network during its initial one-year term. It would resurface approximately the same miles of streets on the Local and Neighborhood Street Network during each of two one-year options. Approval of contingencies will provide funding for unanticipated work necessary for the proper construction and completion of each project.

#### **BACKGROUND**

The Department of Transportation (DOT) is planning to maintain 205 miles during the 2020 construction season. Of that total, DOT will resurface approximately 72 miles of streets on the Local and Neighborhood Street Network and 42 miles of streets on the Major Street Network. During the 2020 Pavement Season, the three contracts proposed for Director's Award in this memorandum will resurface 20 miles on the Local and Neighborhood Street Network and 30 miles on the Major Street Network. Resurfacing of streets generally includes the repair or replacement of damaged pavement, application of a new layer of asphalt, installation of new roadway striping and markings, and installation or retrofit of curb ramps where needed to comply with the Americans with Disabilities Act (ADA).

Paving operations typically occur in the late spring and summer because cooler temperatures prevent proper curing of asphalt. DOT typically brings forward paving contracts for Council award in the spring and early summer; however, the timing of the bid process for these three contracts will not be complete in time for this to occur. Delegating authority to allow the award of these three projects during July will enable the pavement work to occur during the 2020 Pavement Season.

The attachment to this memo contains the list of streets to be resurfaced. The list may change if unforeseen circumstances arise or new information regarding other street-related projects becomes available.

#### **ANALYSIS**

#### OBAG2 San Jose Pavement Maintenance Projects

The OBAG2 (North) and OBAG2 (South) pavement maintenance projects are using Federal One Bay Area Grant (OBAG) funding, which is administered by Caltrans, to resurface a combined 30 miles of major streets. Caltrans provided DOT with authorization to proceed with procuring these two contracts on May 14, 2020 and staff advertised the projects on May 27, 2020. Bids

will be opened in June with the award of the contracts proposed to occur in July. Construction is anticipated to commence in August with completion of the pavement work by November, weather permitting.

#### 2020-2022 Local Streets Resurfacing Project (Multi-Year)

This project is using Measure T funds to resurface approximately 20 miles of City's residential streets in the initial term year (2020) with the option to extend the contract for up to two one-year option periods (2021 and 2022 Pavement seasons). DOT typically awards one-year contracts but is piloting this procurement method because during the 2019 construction season, bids were consistently higher than anticipated due to larger than expected asphalt price and labor costs increases. Acting upon a request of the Mayor, DOT worked with the Department of Public Works and City Attorney's Office to develop a multi-year procurement that might help mitigate large annual price increases. DOT staff also worked with jurisdictions throughout the State of California to determine best practices around multi-year contracts. Staff will assess whether this pilot procurement method results in lower costs and more efficient delivery during the 2020 construction season to determine the action plan for 2021 projects.

The scope of work performed during an option year will be substantially the same as the initial term year, except the work will be performed on different streets. The contractor will need to provide appropriate bonds and insurance during an option year. In addition, the contract provides for price increases related to prevailing wage requirements and the cost of certain materials. Cost adjustments for materials are linked to increases and decreases in certain established indices.

Bids will be opened in June, with award of the contract proposed to occur in July. Construction is anticipated to commence in August with project completion by November, weather permitting, for the initial term. For any option years, construction is anticipated to start in March and complete by July of the respective years. DOT is recommending that the Council delegate authority to the Director of DOT to exercise the options if the Director determines that doing so is more economically beneficial to the City than procuring a new contract for the work.

As indicated above, the proposed delegation of authority will ensure that the pavement work on these contracts occurs during the 2020 Pavement Season, prior to cooler winter temperatures. This delegation will include the authority for the Director of Transportation to hear and decide any bid protests, to make the City's final determination as to the lowest responsive and responsible bidder, or to reject all bids and re-bid the projects.

San Jose Municipal Code Section 7.04.050 provides that the contingency for all public works contracts (except those involving the renovation of a building or buildings) cannot exceed 10% of the total contract amount. Staff recommends an approximate 5% contingency for the OBAG2 projects and a 10% contingency for the Local Streets project, which should be sufficient to account for unforeseen conditions that might arise in the excavation, removal and replacement of

failed concrete areas. Staff recommends a 10% contingency for the Local Streets project to cover potential variability in construction prices in 2021.

#### **CONCLUSION**

Approval of this resolution will enable the contracts to be implemented with scheduled construction to begin in August 2020.

## **EVALUATION AND FOLLOW-UP**

DOT provides an ongoing evaluation of the City's pavement conditions and provides periodic reports on this topic to the Transportation and Environment Committee, and the City Council.

#### **CLIMATE SMART SAN JOSE**

The recommendation in this memo aligns with one or more Climate Smart San José energy, water, or mobility goals.

#### PUBLIC OUTREACH

To solicit contractors, these projects will be listed on an online bid solicitation website, Biddingo, where bid packages were made available to download for contractor organizations and builders' exchange. When the project commences the contractor will provide advance notification regarding working hours, duration of project, and any appropriate schedule and lane closures to affected businesses and residents, as stated in the specifications. To inform traveling motorists of upcoming construction activities and potential traffic delays, changeable message signs may be used on selected streets stating the scheduled date and time for work to occur on the street. This memorandum will be posted on the City's Council Agenda website for the June 23, 2020 Council Meeting.

#### **COORDINATION**

This memorandum has been coordinated with the Department of Public Works, the City Attorney's Office, and the City Manager's Budget Office.
