As San Jose stares down an impressive budget deficit please look closely at how much is spent on housing. What could we have done differently to serve the homeless with \$1 Billion?

Please look at salaries, lucrative pension plans, multiple pension plans, and gold-standard health care benefits inaccessible to most citizens. Public safety is not the first thing SJ should cut.

Since the 2014-2015 fiscal year, San Jose's Housing Department total combined operating and capital budget has been just north of \$1Billion.

Hi,

My name is Sara Gabriele and I am a resident of San Jose.

I am writing because I do not believe our city is taking the degree of action that is needed to address police brutality.

Why are we spending 44% of our budget on policing? Why are our education and social services so poorly funded in comparison? Why are we increasing the number of police instead of exploring more strategic safer approaches (e.g. having a crisis counselor pick up 911, having a social worker in schools instead of an officer)?

We do not need to suddenly fire our police officers. We can and should approach this strategically, such as cutting spending on military grade weaponry and by not hiring back fills for retiring officers.

A vision of a future with these policies is not a dystopia-- it would look a lot like a typical suburb. The low crime rates in these areas are not because of more police on the streets but because they have good schools, good healthcare, and jobs.

In the wake of George Floyd's death, many of San Jose's citizens—including myself—have assembled to protest. We express our frustration and anger with the police system; a system that has roots in perpetuating slavery and still disparages black people to this day; and police officers who grossly exploit their power; for example, the squad of San Jose policemen who incited violence at peaceful protests downtown. With that said, I would like to address a statement put out by Mayor Sam Liccardo. In the statement he rejects calls to defund SJPd in favor of police reform. But I just don't see how we can fix a system that isn't broken—a system that was meant to oppress people. New York City was one of many cities which instated police reform before the spark of protests, but that didn't prevent the NYPD from driving their vehicles into a crowd of protesters.

Mayor Liccardo also says that communities of color are more targeted by crime, but isn't crime merely a response to social conditions? Instead of pouring all \$440 million into SJPd, why not redirect those funds to rebuilding vulnerable communities? Instead of focusing on the punishment of criminals, why not be proactive and prevent crime by allocating funds to help those in need?

Police reform is a band aid fix on a flooding wound. It's time to apply tangible pressure on it. Defunding police isn't a gateway to rioting. What we want is to reroute those funds to aid the root of crime. What we want are resources which are better suited to the community's needs. What we want is to prevent police brutality and keep our black friends and family safe. Please reassess the role of police in our city and allow more community resources to play a bigger role in crime prevention.

Subject: Add To Our Police, Don't Cut Their Funding. Disregard The Anarchists

I am writing this letter over the grave concern that I have about some activists people in our city, or from other cities, trying to discredit and vilify our police department and thereby attempt to reduce our valuable police department or worse, and put our safety at great risk.

I commend our Mayor and Police Chief for standing tall against the violent protestors who changed the character of a peaceful protest against George Floyd's killing into a mob of looters and violent thugs trying to destroy businesses and attack anyone that was not accepting their mission including our police, businesses, and peaceful citizens. They sought to disrupt and destroy parts of our city which is well beyond their constitutional rights. Our Mayor and Police Chief took measured action to save our downtown and our many businesses from what has happened in New York, Minneapolis and Seattle and many other cities out of control that would not confront these criminals.

The peaceful marches protesting of the heinous act in Minneapolis by some rogue policemen in that city does not paint our police department in the same way. While I am sure there are needed reforms in how to deal with certain criminal acts, this does not justify attacking any policemen trying to do their sworn duty to serve and to protect US.

Last year, our home was broken into, and thanks to our police officers on duty that day, they quickly responded to my wife's 911 call. They made sure that she was safe and searched our home to insure that this criminal was no longer there. When I got home and spoke with the officers, they were highly professional and made sure that my wife and I, and our neighbors, were alright. They were courteous and sympathetic to our situation. Thank God they were there to help.

This is one of many experiences that I have seen in our local neighborhood with our police responding to very difficult safety concerns. Our police are the one thin blue line between peace, order, and safety versus criminal chaos and anarchy as we have been watching non-stop on our TVs the past two weeks.

The death of George Floyd was a criminal act and those bad police officers are being incarcerated as they should. People should rightly protest any truly malicious acts of police beyond their duty and responsibility. Yet, when peaceful protests turn into mob rule with harmful and deadly consequences to police and citizens with wanton destruction, then those violent protestors become the criminals needing swift and strong action by our appointed authorities.

Back in 2009 we faced the loss of both budget and substantial police staffing as a result of the great recession. In the next several years we saw growing crime throughout our city and in our VEP South San Jose neighborhood where I live. Fewer police meant greater crime and property loss to us citizens and taxpayers. Thankfully, the hard efforts by our Mayor and past council and police representatives we have added back more police and are seeing more trainees going through our great police academy.

Now, again, in the heat of emotion, many good intentions by poorly aware people are calling for the cutting of our police force. Some, even want our police eliminated. If this ever happened, our city would fall into total chaos with no one there to protect the citizens or businesses and answer our 911 calls. Major investment in our downtown would be abandoned, and many taxpayers (the source of city revenues) would give up and move elsewhere, leaving us with a desolate scene with crime and criminals like the MS-13 gang and drug merchants running freely and with a bigger unfunded city budget deficit with everyone crying for free stuff!!

Then, the only protection would be the residents themselves self-arming and policing their own neighborhoods, like Willow Glen did several years ago when no one was available in the police department to answer the call. What is that risk to all?

So, now is the time to think soberly as our Mayor and Police Chief have shown. Now, is the time to add more professional police help to achieve full police staffing and add more training to our police academy and active police training programs to avoid controversial practices. Now, is the time to reject the easy cry to cut our police from emotionally charged, yet mindless people.

We cannot afford to turn our city over to criminals, anarchists and extreme agenda Mob people. Now, is the time to reinforce our city as one of the safest in the U.S. As council members, you must lead and protect the peace, not destroy our very tools and resources that protect us.

Safety and our police are our #1 city priority and core service. You have nothing left, including our tax base, if our citizens are not safe from the violent, the criminals and the Mob. You cannot afford to turn social justice goals into crime and mayhem. It is not the police that we should fear.

In the name, spirit, and memory of those killed by San Jose police, we — the families of those killed by the San Jose Police Department, the supporting community, and those who have called for Black Lives Matter from the streets — submit this letter demanding the defunding of the San Jose Police Department.

To fully grasp the urgency and sanctity of this call, before reading the arguments, analysis, and reasoning collectively crafted below, we ask you first to say out loud the names of San Jose loved ones who have been killed by law enforcement and whose families author and lead this cry for justice:

*Rudy Cardenas, Richard Harpo Jacquez, Jacob Dominguez, Antonio Guzman Lopez, Richard Lua, Isai Lopez, Jesus Geney Montes, Anthony Nuñez, Daniel Pham, Aaron James Phillips, Steve Salinas, Diana Showman, Cau Bich Tran, Phillip Watkins, Jennifer Vasquez.*

These are names you should know by now, and is not even an exhaustive list of the lives taken by law enforcement in San Jose. The families of those murdered by police in San Jose have been calling for justice and accountability for years. They have united to find strength and solace to organize through their tragedy, and the call for ending police violence, to replace lethal police functions with community responses, to divest from the weaponry that took their loved ones lives are mandates that they have long made a local struggle and now is echoed as a resounding national, history-changing, movement. As the renown abolitionist Angela Davis noted in a recent interview, in regards to the magnitude of this moment she says, “We have never experienced this kind of global challenge to racism and the consequences of slavery.”

The murder of George Floyd in Minneapolis ignited not only a new national consciousness, it has inspired unprecedented political action across the country and globe. San Jose has been no exception. Our community — led by young Black and brown leaders — have boldly and beautifully ceased the city, chanting, marching, protesting to say the injustice will not be ignored, the murders must stop, and Black Lives Matter.

The City of San Jose responded to the righteous protests by launching flash bang grenades that shatter eardrums. The City of San Jose let loose barrages of rubber bullets at point blank range that seriously injured protestors who are there to denounce the very treatment they’re receiving at the hands of the San José Police Department, leaving our own community wounded, traumatized, and, for some, perhaps unable to even have children that can grow and flourish in this beautiful community.

They shot tear gas at us as we chanted “I Can’t Breathe” through withered facemasks, while Jared Yuen, “a good kid” in uniform, with your name on their badge leered at us, gun cocked, and yelled, “Shut up B—ch”.

Communities like ours, around the country and the world, have been taking to the streets in the hundreds and thousands in support of the Black Lives Matter movement since the hideous murders of George Floyd, Breonna Taylor, Tony McDade, Nina Pop, and countless others at the hands of their own police departments. The Black Lives Matter call started as a response to Trayvon Martin’s unjust murder and is a platform for black and brown communities to fight for justice, freedom and liberation through community organizing and action.

After decades of broken promises and empty reforms, Black and Brown communities continue to be the targets and victims of police violence, abuse, incarceration, as the budget for SJPD balloons at the expense of community programs. The numbers are irrefutable — 44% of the general fund department's budget is committed to the police as housing, parks, education, and health needs are deprioritized and stripped of resources. The budget allocation is an articulation of this perpetuated systemic racism upheld by elected city officials.

But now, San Jose, through this upcoming budget decision, has an opportunity to move to the right side of history, and our families and communities implore you to be responsive to the demands that is ancestral in the making, that are from San Jose parents who will not hold their children again, of kids who now grow up without mothers and fathers, and is for future generations to come.

The following demands are organized as a divest in police and invest in community framework. Each of our two major sections labeled “Defund” and “Reallocate” has itemized demands which were collectively researched, analyzed, and agreed upon. Each demand stems directly from the experiences of the families who lost loved ones to police and the urgent needs of San Jose’s Black and Brown communities.

## DIVEST

- Remove police officers from the force who were responsible for officer involved shootings.
- Dismantle units such as VCET, MERGE, Covert Response and Street Crimes Unit that have displayed the highest propensity for violence against Black and Brown communities and criminalize poverty.
- Dismantle the Mayor’s Youth Gang Task Force which is a law enforcement surveillance and targeting mechanism disguised as youth services.
- Eliminate paid administrative leave for police facing misconduct charges.
- Do not allocate City funding for the defense of officers who shoot, maim, or injure our loved ones due to police violence.
- Discontinue all future hires and training, and remove any current openings, beginning in the fiscal year 2020-2021.
- Restrict further use of the \$178 million CARES Act funding to: hire, recruit, or expand SJPD force; prepay pensions for SJPD officers; purchase additional tools, materials, or supplies; contribute to construction or repairs of any Police-related buildings, offices, or facilities; fund redistricting efforts; or fund the perpetuity or expansion of police-related activities.
- Disarm the police by cutting their non-personal/equipment budget.
- Demilitarize the SJPD by restricting the department from receiving funding for equipment from our State and Federal government.

## INVEST

- Allocate grant funds only accessible to black led community organizations.
- Provide funds for immediate and long term support for individuals and families impacted by police violence.
- Allocate grant funds to Brown and other low-income communities, prioritizing areas that are over policed and under resourced.
- Fund the development of a new sector of first responders to directly respond to 911 calls for help.
- Fund long term mental health resources.

- Use the CARES Act funding to immediately relieve the rent of all those unable to pay their rent during shelter in place orders.  
Provide long term funding to support San Jose's housing needs and investment in San Jose's community-led land trust.
- Reallocate and restore funding for community parks and recreation spaces and programming.
- Restore funding for San José Public Library staffing and programming.

We as a united San Jose community formally submit the above listed demands as a necessary shifting of resources to match the values, principles, and immediate needs of our people. We call on each of you as elected officials to fulfill your responsibilities to the people of San Jose and honor the vision laid out which guided by families who lost loved ones to police, and is rooted in the safety and well-being of all of our residents. We will not tolerate any more taking of lives by police, and certainly will not accept the murders to be facilitated through our public dollars especially while critical community resources remain depleted. This demand to defund the police is as much about stripping an institution of the budget it has used to harm and kill, as it is at the same time an intentional re-investing in a community budget, particularly Black and Brown San Jose communities, who have been drained of resources systemically for generations.

Our call is as practical and timely as it is aspirational and forward-looking. We are ready create a San Jose where our impacted and targeted communities imagines and determines what safety and well-being looks like and means for all of us. And we fully know, without a doubt, that this demand letter articulates our first and most critical foundational step in making that San Jose a reality.

This is in response to the reprehensible conduct of SJPd towards protesters in downtown San Jose with tear gas and rubber bullets while they were lawfully exercising their right to peacefully protest under constitution, and the amount of money allocated to the SJPd in the budget.

I am a homeowner in San Jose and I pay very high taxes and I want the city of San Jose to divest in the police and put that money into programs that help individuals in the city of San Jose.

1. Remove police officers from the force who were responsible for officer-involved shootings.
2. Dismantle units such as VCET, MERGE, Covert Response, and Street Crimes Unit that have displayed the highest propensity for violence against Black and Brown communities and criminalize poverty.
3. Dismantle the Mayor's Youth Gang Task Force, which is a law enforcement surveillance and targeting mechanism disguised as youth services.
4. Eliminate paid administrative leave for police facing misconduct charges.
5. Do not allocate City funding for the defense of officers who shoot, main, or injure our loved ones due to police violence.
6. Discontinue all future hires and training and remove any current openings, beginning in the fiscal year 2020-2021.
7. Restrict further use of the \$178 million CARES Act funding to hire, recruit, or expand SJPd force, prepay pensions for SJPd officers or purchase additional supplies.
8. disarm the policy by cutting their non-personal/equipment budget.
9. Restrict the SJPd from receiving funding for equipment from our State and Federal government.

Instead, invest the money in these programs:

1. Allocate grant funds only accessible to Black-led community organizations.
  2. Provide funds for immediate and long term support for individuals and families impacted by police violence.
  3. Allocate grant funds Black and brown low-income communities, prioritizing areas that are over policed and under resources.
  4. Fund the development of a new sector of first responders to directly respond to 911 calls for help. These responders should replace police as responders in calls that are related to mental health, sexual assault, assault/gender-based violence and abuse, and substance abuse. These responders should be trained in de-escalation practices, transformative/ restorative justice, and other ways of intentionally addressing the calls.
  5. Fund long-term mental health resources.
  6. Use the CARES Act funding to immediately relieve the rent of all those unable to pay their rent during shelter in place orders.
  7. Provide long term funding to support San Jose's housing needs and investment in San Jose's community led land trust.
  8. Reallocate and restore funding for parks and recreation spaces and more funding for education in under funded communities.

Dear Mayor Liccardo and Councilmembers:

As you know, I am a constituent and a neighbor to City Hall. I've been at many protests and listened to many hours of public comment about the problems with SJPd. Sunday's march from City Hall to Civic Center was peaceful without the worry of being shot with rubber bullets or choking on tear gas. But we honored the many San Jose residents killed by SJPd who are not here to complain about shattered kneecaps or gonads, as well as advocating for abandoning this racist system.

I was shocked and dismayed to learn that 44% of our city budget goes to SJPd and this is why we "can't afford" to provide city services that would help strengthen our community. This is the local government equivalent of the Pentagon always having funds for missiles but HUD has to cut housing funding and we can't afford Medicare For All.

I appreciated what Councilmember Peralez had to say on Friday about how many police calls are for issues that either don't require an armed sworn police officer or that are made worse by police response. The police should not be enforcing health codes on food vendors; the Health Department should do that. The police should not be trying to talk people off bridges; the Crisis Team should do that. The police should not be harassing unhoused folks for "quality of life" issues that are just criminalizing being unhoused; the Crisis Team or Housing Department should help them get housing and supports. If the City's budget for housing is such a tiny fraction of the total, it would take very little of the police budget to increase Housing by a factor of 10 and end "homelessness" as we know it.

Sunday afternoon, I joined about 300 other members of local faith groups to deliver our 95 Theses of Public Safety to the police department. We marched peacefully from City Hall to the County Jail building and read all 95 theses to the crowd before gaff taping the banner of 95 Theses to the barricade in front of the jail entrance. This action could have been larger if we had waited--but we needed to act in time for the City to incorporate our requests in the budget.

My name is Sarah Hollingsworth, and I am a member of Showing Up for Racial Justice at Sacred Heart. I am an active voter, a resident of Campbell, and a teacher in Los Gatos. It's clear that the SJPd isn't keeping people safe. During these challenging times, we need to re-invest the budget allocated for police to community-led health and safety strategies. It is unacceptable that the police department is granted a larger sum of money from the general budget during the COVID-19 budget shortfall, all while community programs are being cut.

I stand with SURJ and other community organizations that demand an immediate reduction of police funding by 50% including reduced field patrol, closing the METRO (VERGE and VSET) program, the Street Crimes Unit, and the Covert Response Unit within Investigations. We demand termination of police officers for any involvement in police shootings, excessive force, corruption, sexual abuse, physical abuse, domestic abuse, or discrimination. We demand that the City eliminate the Mayor's Youth Gang Task Force, as law enforcement uses the task force to covertly surveil black and brown youth. We demand that \$19 million from the CARES ACT be reallocated from the police to renters on the brink of eviction. We demand that you reallocate the funds cut from policing to community-led "alternatives to policing," the Black community, the underserved community, and underfunded community programs.

It is imperative that white people and our city leaders take responsibility for the ways that systemic racism and white supremacy are perpetuated through institutions like our government and the police. It is your duty to dismantle structures that continue to oppress people of color, especially people who identify as Black, Indigenous, and Latinx. This includes our undocumented residents who are particularly vulnerable.

This is not just a matter of equity and justice it is a matter of liberation for us all. Systems of oppression are bad for society, all the way around. It is vital that we understand our real history as a country that was stolen from Indigenous people and then built on the backs of enslaved people who were stolen from their lands. My name is Kate Jackson and I am a high school student and resident of San Jose. I am writing to address some major concerns regarding your response to recent protests against police brutality.

First, although I applaud any efforts against systemic racism, I found your proposition to implement various reforms within SJPd to be entirely insufficient in addressing the continuing crisis. Reforms such as additional independent police auditors, diversity training, psychological screenings, and more selective recruitment have existed in America for decades to no avail. By repeatedly carrying out disturbing acts of brutality on camera, police have shown us that no amount of accountability can stop these blatant acts of racism so long as they have the backing of the system. Implementing ineffective reforms is a form of complacency which allows violence to continue and more Black lives to be lost, as we await substantive change. This is unacceptable.

Instead I ask that you reconsider the idea of defunding the police which you have already dismissed in recent weeks. To many the catchphrase "defund the police" incites images of chaos and lawlessness. However, such extreme interpretations reflect a general uninterest in the potential value of this proposition to reimagine the way we do policing in San Jose. Understand that I am not asking you to stop funding the police completely, but rather redirect substantial funds into SJ programs that directly support Black lives and the needs of our community: mental health, addiction recovery, housing, education, and bridge programs for recidivism prevention.

Hello,

My name is Alyssa and I am from San Jose, Ca. Being a resident here my whole life, I have a true passion for the city in which I grew up. It concerns me that in the following proposed budget (<https://www.sanjoseca.gov/Home/ShowDocument?id=59606>) there is little mention of education.

I was very frustrated when I read: "But if "defund" merely represents a mechanism by which we slash police budgets as a means to express protest, I disagree strongly. The appropriate response to protest is to reform, not to defund." Yet education has been defunded for years. Why have we not decided to "reform" the education budget? Instead we take away enrichment opportunities for children in music, PE, art, science, and social studies. Where was the reform then?

The little mention of education in the budget is to allocate 11,000 hot spots provided by AT&T to support learning in the fall and close the digital divide. Awesome, great plan. However, 11,000 is a very small percentage of the population of children who need access to the internet. How do you plan to allocate the hotspot resource? Many companies offering to provide "free" hotspots in the beginning of COVID required people to register online. How could they if they do not have the internet to start with? Many families also come against a language barrier. How will you ensure families who do not speak English as their first language will have access to apply for such an opportunity? Again an awesome plan because there are families who need the internet, however, be sure there are enough resources and families with certain barriers will be able to have the same opportunity.

On the other hand, access to the internet may not even be the problem. It is a lack of devices. Students at home have siblings and parents who have to work from home as well. Many families are limited to one device. This may cause interference with one student who has to turn in work at a certain time or a student who may miss their live Zoom/Google hangout class. There was no mention in this in the Digital Divide section as this is a digital divide. Many families can not afford multiple devices.

All in all, I don't think a 44% budget would be hurt with a 5-10% decrease in funds. The police budget in our city takes up nearly half of the budget. A reallocation of those funds could support other areas to continue to make our city of San Jose, of the best, biggest and safest cities in the world. You said it yourself in the proposal that our law enforcement is



not the same size as other large cities in the US including LA, then maybe our budget should not be the same size as theirs?
