presented my concerns and opinions of the project. Two things I would still like to bring up again.

First, with a tall structure, I am still concerned about the shadowing effect on my yard and my house due to the height. I am basing on the shadowing effect created by the five storey building at 1432 WestSan Carlos Ave (called Meridian at Midtown and located at southwest corner of West San Carlos and Meridian Ave). I have observed that building casts a shadow northwards, that covers up all of West San Carlos street, both north and south sidewalks of West San Carlos. This shadow, in my estimate, is about 110 feet long (based on 75 feet wide West San Carlos street and two 15 feet wide sidewalks. So with a similar tall building adjacent to my property, you can see why I am worried about the shadow it would create and cover my yard and the house. This is why, I still think the proposed building is too tallis there any chance that the height will be lowered? Second if they decide to plant trees along the north property line adjacent to the three Norton

Avenue properties, I would suggest that they plant Italian Cypress trees which are skinny and not wide and can be no more than 15 to 20 feet

Italian Cypress trees which are skinny and not wide and can be no more than 15 to 20 feet tall. Please do NOT plant trees with wide canopy.

No Sycamores! No Sequoia or Redwood family trees! They are too wide and tall and cause more shadowing which would affect my vegetable

garden and fruit trees. Also they shed too many leaves and needles and a pain to clean up.

In the lead up to Juneteenth today and in this moment in our country of important social change, I've been reflecting back this week on some of the words of Martin Luther King Jr. in his "Letter from a Birmingham Jail."

Dr. King talked about his disappointment with the "white moderate," who "prefers a negative peace which is the absence of tension to a positive peace which is the presence of justice; who constantly says: 'I agree with you in the goal you seek, but I cannot agree with your methods of direct action'; ... who lives by a mythical concept of time and who constantly advises ... to wait for a 'more convenient season' ..."

As a grassroots community-based organization that accepts no money from the development community, Catalyze SV often engages in direct action and advocacy, urging developers & governments to built the most sustainable, vibrant, & equitable projects possible on behalf of the community.

- We sometimes do this through healthy tension the back-and-forth conversations with developers & city employees about building developments that bring the greatest good for the greatest number of people.
- Our approach resists the temptation to wait for a "more convenient season" for the number of homes we need now.
- We push back on the often quickly discarded promises of "let's make the next project better, not this one."

• We reject the fear, impatience, or skepticism that drives some to resist the long-term engagement & process necessary over multiple months to make projects that will last many decades.

These conversations & this approach bear fruit that align with the goals of this City Council on priorities such as housing production, shifts in mobility, & environmental sustainability. There are few better examples of the results of Catalyze SV's model then on the 259 Meridian project before you on Tuesday, June 23.

Before we get into those results, let's share credit where it is due: Catalyze SV has rarely encountered a developer as willing to listen to collaborative input from our members & incorporate those constructive ideas into its project as Strangis Properties. Jerry Strangis, Anthony Ho, John Moniz & the rest of their team should be commended for their responsiveness!

Catalyze SV believes they have submitted an excellent proposal deserving of our support and yours. Yet for this proposal to get as good as it is now, it took a great deal of effort by Strangis Properties and city staff, with repeated input from Catalyze SV.

In 2018, the developer brought this project to CSV. Frankly, it was just average and our members scored it that way then. But to their immense credit, the developer kept engaging with Catalyze SV, reading <u>our</u> <u>scorecards</u> and our <u>requests for follow up</u>. And they kept making revisions to their proposal.

Fast forward to last month: Strangis Properties presented their much improved final proposal to the Planning Commission. Here's much of what changed in the proposal over the course of 18 months based on the input Catalyze SV gave:

- On <u>affordable housing</u>: Since 2018, Catalyze SV has said we want the affordable housing units to be built on-site. A few weeks ago, Strangis Properties changed course and decided to go the route of building 15% of the homes on-site as affordable.
- On <u>family-friendly housing</u>: We gave the developer positive feedback on their initial idea of building micro-units while making the case for more family-friendly housing too. The final proposal includes both micro-units AND two-bedrooms.
- On the <u>parking to homes ratio</u>: We told City staff & the developer we don't support more parking & less housing, helping support the goal of more homes, our community's greatest need when it comes to development.
- On <u>encouraging transit versus more car traffic</u>: Strangis Properties is providing residents with a monthly "mobility stipend" that may be used for services such as transit passes or bike share to balance having fewer parking spaces.
- On <u>environmental sustainability</u>: Strangis Properties increased the number of trees & adopted native landscaping.
- On <u>community engagement</u>: Strangis Properties went to neighborhood groups we suggested they engage.

• On <u>vibrancy</u>: Strangis Properties added public art & made the plaza a 24-hour space for the neighborhood

These are the awesome results when community members as part of an organization speak up on behalf of the broader community for equity, vibrancy, & sustainability.

We will continue & fine-tune this approach because it leads to better outcomes for our community. And because every project Catalyze SV members have reviewed that went to the San Jose or Santa Clara Planning Commission or City Council for a vote has passed.

So you see, the "tension" created from our approach & process leads to positive outcomes and, dare I say, the presence of justice. A just community in which more people can afford to live, breathe cleaner air, live healthier lives with more walking & less driving, have more access to community amenities we can all enjoy, & live in more integrated communities.

This project is another step in the right direction. Even when we have to reluctantly embrace the difficult work for us to come together & build consensus, let's keep moving in that direction as quickly as we can.
