SUBJECT: APPROVAL OF PARKS AND RECREATION MONTH SPONSORED BY COUNCIL DISTRICT 8 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

- Approve Parks and Recreation Month to be recognized by the City Council on Tuesday, June 30, 2020 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses or community groups to support the event.
- 3. Place the item on the Tuesday, June 30, 2020 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

In lieu of a City Proclamation, Parks and Recreation Month will be recognized by the City Council on Tuesday, June 30, 2020 and sponsored by Councilmember Arenas. National Park and Recreation Month is typically celebrated every July to mark the importance of open space and recreation for both the physical and mental health of our communities.

Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
