In that capacity, I developed intimate understanding of the rules and regulations that applies to new developments in San Jose, such as the Ellis Act and the Inclusionary Housing Ordinance. On the Housing Commission, I led the effort to recommend to the City Council that we enact the Commercial Linkage Fee and to study residential vacancies in San Jose. Outside of the Housing Commission, I have worked with organizations representing mobile home residents to advocate for a new general plan designation to apply to mobile home parks.

The Planning Commission plays an advisory role to the City Council on matters related to the General Plan, to our growth, and to our development. While it does have final authority on some matters, the Planning Commission - like any other commission - is intended to provide community feedback to the Council as it is comprised of non-elected officials.

The Commission's top priority should be generating ideas to increase the housing supply for the LI, VLI, and ELI population. The City is on track to meet its market rate housing goals, but falling far behind on its goals to meet affordable housing goals. Second, the City should prioritize the assessment of how additional housing will affect the ability of the City to continue its current level of services, such as garbage and law enforcement. Third, the City should work with its communities, developers, and other stakeholders to develop a plan to boost the housing supply while matching any growth in the need for services or resources for the additional residents who move in to San Jose.

I have served on the Housing and Community Development Commission (HCDC) since August 2018. In my time on HCDC I've learned a lot about how internal city processes work, and particularly brought me up to speed on developer obligations like affordable housing, parks, and parking minimums. HCDC has also given me experience hearing different, often conflicting, perspectives from different stakeholders, and having to weigh those wants and needs when making a decision.

I've been involved with the District 1 Leadership Group (D1LG) for several years and was elected to serve on its board in January 2020. The D1LG has connected me to many of the people and organizations involved in the planning process, like neighborhood associations and other resident groups, developers, advocacy groups like CatalyzeSV, and council staff. I also regularly attend public comment meetings for projects in my area. I've developed a good understanding of who cares about planning and why, and how the process tends to play out when projects are controversial. If I serve on the Planning Commission, I'll use those connections to help keep the community informed and involved in the planning process.

What is your understanding of the purpose of the Commission?

My understanding is that the purpose of the Planning Commission is to advise City Council on planning policy (such General Plan amendments and land use ordinances) and individual planning decisions for proposed projects. I also understand that the Planning Commission has limited authority to act independently of City Council to issue some types of permits.

Please list three issues facing the City that you feel the Commission should address.

The City of San José has recognized for years that new housing construction is essential to address California's housing crisis. Unfortunately, many other cities in California have approved very few housing projects since the Great Recession, including some of our smaller neighbors, and that's spurred the state to take action to restrict local control. I'm deeply concerned that such laws will unfairly limit San José's authority to decide how, what, and where we build, even though we've exercised that authority responsibly in the past and will continue to do so in the future. If San José has to modify its ordinances or General Plan to comply with new housing legislation, I hope that the Planning Commission can reconcile compliance with the law and maintaining local control. --- Addressing the housing crisis with density and development and protecting vulnerable communities are sometimes competing goals. There's never a one-size-fits-all solution, so this is a challenge that the Planning Commission and the City Council always need to keep in mind. The recent General Plan amendment to rezone and protect mobile home parks was a great example of the Commission and Council "promot[ing] San José's continued growth into a leading world city, while maintaining social equity in its operations," the first major strategy of the city's General Plan. --- Parks and open space are essential for health, wellbeing, and quality of life in our neighborhoods, and for achieving Major Strategy #13 of the General Plan, "Design for a Healthful Community." That's become even more salient during the current pandemic, as our parks provide an outlet for exercise and recreation during the ongoing shelter-in-place order. But some parts of San José have less access to parks than others. For example, District 1, where I live, is largely residential, but has fewer parks than any other council district. It's important for the Planning Commission to understand the value of parks and open space in our community and use its charter as an opportunity to promote the creation of new parks and open space.

I want to serve on the planning commission to contribute toward building a better San Jose for the futureit's a goal my family has worked toward for generations in this valley and one I wish to continue using my own skillset.

To understand my sense of obligation, I wish to share a little family history. In 1905, my great-grandmother emigrated from northern Italy to San Jose through Ellis Island. Soon after, her mother died, and she was removed from school, tasked with caring for her three siblings, before she learned to read or write. In 1926, she gave birth to my grandfather at her bungalow on Delmas Avenue (a property later taken by eminent domain). She instilled in him a relentless work ethic and the importance of education: she worked nearly her entire life pressing clothes at San Jose's Linen Exchange. My grandfather spent his childhood working in San Jose's canneries and orchards while attending San Jose public schools. He was the first member of his family to attend college: San Jose State University. After obtaining his degree, and completing military service, he returned to his hometown: as an educator. For nearly twenty years, my grandfather was a teacher and administrator in SJUSD; his sister also spent her entire career working in SJUSD. He told me there was no greater joy that he experienced during his life than those years as a "boots on the ground" educator.

My grandfather, who passed away last year at the age of 93, instilled in me the same work ethic he learned from my great grandmother. During our many conversations, he emphasized the equal importance of education and contribution to one's community. I want to do my part, and ensure I continue the legacy of contributions my family has made to the City.

To this end, my primary objectives as a Planning Commissioner are three-fold: (1) approve projects that add sustained value to the City of San Jose and its various communities; (2) have informed exchanges with the public and other commissioners about the compatibility of the particular project with the General Plan aimed at balancing the interests of San Jose's diverse stakeholders and community members; and (3) execute the vision of the San Jose 2040 General Plan, including the judicious exercise of discretion provided to Planning Commissioners in evaluating a project's suitability.

Without cutting and pasting what is written on the City's website, I would sum up the Commission's purpose as that of an advisor to the City Council on land use and development matters. Also, beyond reviewing projects and decisions for conformance with the City's policies, the Commission can use its position to flag issues for the City Council to address.

Please list three issues facing the City that you feel the Commission should address.

I believe the most important issues for the Commission to address are: 1) Race/Equity: After Trump was elected. I became fairly obsessed with trying to understand certain elements of society that were emboldened by the new administration. I spent about 2 years doing some deep learning and came to understand that my worldview, despite perceiving myself as a good progressive, was far from the truth. Since that time I have learned a lot about structural racism and believe that the number one issue we need to address at this time is our seemingly race neutral approach to policy and systems. I have unknowingly perpetuated solutions that I have thought were fair, but they were skewed. I have been in positions of power and not wielded that power justly. I know few in power who do. This is the top issue of today. 2) Sustainable Development: As an environmental studies major, I come to land use and development by way of the environment. As a result, I believe one of the best strategies for improving the health of the planet is to direct development to the appropriate places. I believe Planning Commissioners can be successful ambassadors and messengers in this regard and would attempt to use my position to understand, address and bring along those who are wary of the unknowns that go along with change and growth.
