Dear Mayor and Councilmembers,

I ask you to extend terms of all board and commission members expiring on June 30, 2020 that are otherwise **not** eligible for re-appointment; and, I ask you to extend the terms of all Neighborhoods Commission members to June 2021. This involves equity and fairness.

I am a member of Arts Commission. As part of the commission streamlining process several years ago, four Arts Commissioners were given terms of 6 years rather than the 8 years approved by Council. COVID-19 shortened our terms by another 4 months resulting in actual terms of 5 years 8 months. Please note that of the four Commissioners ineligible for re-appointment, **three are people of color.**

During Art Commission's 2019 budget discussions, several members expressed the desire to have more information and asked to form an ad hoc committee. The OCA Director pointed out that we were talking about **equity and access.** That is what we named the ad hoc committee I have chaired for the past months. I want time to complete that work and report out to my fellow Arts Commission members.

You are all painfully aware of the collapse of the hospitality industry with no idea when or if it will fully recover. Currently, most all of the funds that Arts Commission advises City Council to adopt during the annual budget process (Transient Occupancy Tax) are generated by the convention business. As you stare into a potential financial abyss, why not retain experienced commission members?

When many Arts Commissioners first requested an extension, there were no names brought forward publicly for appointment. I acknowledge that those nominated may feel great disappointment if not allowed to assume office on July 1. Many of us waited years so we understand. I pledge to do everything in my power to ease their transition regardless of any decision you make today.

I submit that an extension of our term date is a good trade-off during these challenging times. It benefits the City and allows incoming appointees a unique opportunity to observe Arts Commission meetings via Zoom. Currently, Commission meetings are not videoed with only action minutes available online. Thank you for your consideration during a very hectic time.


Honorable Mayor and City Council members,

Hello Mayor and Council,

I would like to show my support for Councilmember Khamis memo to extend commissioner terms to June 2021.

Commissions have not met since Feb and as result four months of meetings were lost.

Commissions do not meet in July or December so extending to December as the Mayor states in his memo is not giving much additional time to continue the work that is going to be needed in the aftermath of Covid-19. The Arts commission has been decimated by the loss of our TOT, which will be almost non-existent in the foreseeable future.

Allowing extension of commissioner terms until June 2021 will also keep commission onboarding consistent with the city clerks current practices of commissioners terming out in June and new commissioners beginning in August.

A few of us tried to get this memo to council prior to the appointment of any new commissioners. There were no names that had been brought forward when we started the process of requesting an extension. In the past two weeks since rules committee the seats have now been slated. I know those that have been appointed will be disappointed to not begin their terms July 1st and I completely understand as I too had to wait for my seat on the Arts Commission. However it is not uncommon to wait up to a year to get on a commission.

We talk a lot about equity lately and I'd like to share my equity story.

When I was appointed to the Arts Commission my first term was for two years instead of a four. I was appointed during the streamlining of commissions.. As a result I was given a total of six years instead of eight. Now due to Covid-19 I am only serving 5.5 years. I lost 2.5 years as a commissioner, which is not fair to me, but unfortunately that's how it is. I could be angry and bitter about this, but I am not. If we hadn't entered into a pandemic and budget recession I would of gladly resigned my seat this month.

I realize not everyone on this list might want an extension, but for those of us that do I ask that you please extend terms to June 2021 and not shorten my term even more.

Thank you for the way you continue to guide our city and her people through this time of economic recession and hardship. It is a time of anxiety and uncertainty.

Many of those greatly affected by the fallout of the pandemic include our already vulnerable artists and arts organizations. Arts-based businesses of all kinds – theatres, choirs, symphonies, operas, museums, galleries, dance schools – are all trying to assess their next move, stay alive and open in some form, and employ anyone they still can.

The San Jose Arts Commission plays a vital role in providing City Council with advice and recommendations on City policies and programs that affect public access to a wide variety of arts and cultural opportunities.
