

The proposed charter amendment of Item G9 is nothing less than a power grab in response to the public outcry related to white supremacy in this valley and nation, supported by the very corporate interests that benefit from the white supremacy yet again exposed by scholarly research this week, rightly named a *Pain Index*. The proposed amendment grants power to silence representation of people of color to the office of the mayor. It would diminish the voices of people of color -- who would find their council members' power reduced, and replaced with a stronger mayor, particularly the current mayor. We are deeply concerned about changes that would give the current mayor an extra two years in office without voters being given that question directly. The mayor himself, in his proposal, states that his leadership has been widely criticized and controverted, challenged -- and yet, he again fails to see that it is his patriarchal, domineering mode of operation that must be amended. He continues to disregard the voices of others and lives up to his reputation of believing he is the smartest person in the room who alone knows better than the rest of us.
