REASON FOR SUPPLEMENTAL

This supplemental memorandum is being provided to update the City Council on the status of City Council Committee, Board, and Commission meetings.

BACKGROUND

In response to the Stage 5 (Extremely High Response) of the City's Pandemic Management Plan related to COVID-19, combined with the Governor's Executive Order and Region-Wide Order both designed to slow the spread of COVID-19, City Council Committee, Board, and Commission meetings, with a few exceptions, were approved to be cancelled from March 19, 2020 through June 30, 2020.

Specifically, at the Rules and Open Government Committee meeting on March 25, 2020 and City Council meeting on April 7, 2020, City Council Committee, Board, and Commission meetings were approved to be cancelled from March 19, 2020 through April 30, 2020, with the exception of the following:

- 3) Police and Fire Department Retirement Board;
- 4) Work2Future Board;
- 5) Planning Commission; and
- 6) Historic Landmarks Commission.
