IN MY HUMBLE OPINION:

The rush to change the charter to a strong Mayor form of Government is a rush that is driven not as much by need but by political expedience by special interests,

With little, or no credible community process to discuss the merits and the minuses of such a change, we would, like President Trump. be guilty of voter suppression. In 1978, then Mayor Janet Gray Hayes appointed a diverse charter review committee that spent a year studying various forms of municipal government structures. At the end of exhaustive research and discussion, the Committee submitted a recommendation calling for District elections, which the voters approved resulting in elections to the Council by district. The community dialogues on the subject were widely debated, and the majority of the electorate favored the Charter Change.

It seems to me that if Mayor Liccardo is interested in advocating for the best interests of the electorate over his own self interest, he would be wise to assemble a Charter Review Committee that would study the issue more broadly than is the case today. A major change to the city charter should have a real and substantial process for community engagement -- but that's something alarmingly missing from the proposal to the rules committee today. I am also very concerned about changes that would give the mayor an extra two years in office without voters being given that question directly. Last, and most of all, this proposed charter amendment appears to be a power grab, that would move power into the office of the mayor. This would diminish the voices of people of color -- who would find their council members' power reduced, and replaced with a stronger mayor. Given that there has only been one person of color to ever hold this office, the net effects of moving so much power into that office will be to reduce the power of communities of color in San Jose. It's these questions that would benefit from a thorough community process. I ask that the Council defer the item, and first convene an process for community review of our current council-manager form of government to provide recommendation for a ballot proposal. Thank you

As a retired San Jose City employee, this proposal greatly interests me. When I started in 1970, I was told that we had a strong city manager - weak mayor structure of government. Over the years, I made comparisons between my employment at the city to that of friends and relatives who worked at other agencies. I saw that San Jose was more steady and didn't get whip-sawed by changes in elected officials, their appointees and their political agendas.

It seems there is a great variance in the ability of elected officials to manage a large city. However, when a group of elected officials chose a city manager, that person tends to have the required management ability. During my time at the city, I saw about 5 city managers and 5 mayors. My observation is that the managers were more effective than the mayors.
