




### COVID-19 Response

**Community-Facing Work + Concurrent Funding/Reimbursement** 




**Timeline**

# Advocacy

- Fourth Stimulus Package
  - House Democrats introduced HEROES Act
  - \$3 trillion package
    - Elements include:
      - Extension of \$600 unemployment insurance
      - Direct stimulus payments to taxpayers
      - \$375 billion to counties and cities, \$500 billion to states
      - Rental assistance, CDBG
  - Status Senate Republicans potential package after July 4th
- Joint Advocacy delegation, leadership, and through Associations and national partnerships
