Re: Naming Japantown's Newest Public Park

Dear Mayor Sam Liccardo, City Councilmembers, PRNS Staff, and Commissioners Daphna Woolfe, George Adas, Lawrence Ames, Trami Cron, Rudy Flores, Andre Morrow, and Kelly Snider:

IBEW Local 332 is responding with strong objection to the San Jose Parks and Recreation Commission's decision on March 4, 2020 to nominate "Sakura Park" as the name of Japantown's newest public park.

During the Mar. 4 meeting, the Commissioners overruled the recommendation by the city's Dept. of Parks, Recreation and Neighborhood Services (PRNS) that the park be named after John Heinlen or Heinlenville, choices that received the highest number of votes in four public, citywide PRNS surveys. This usurps the consensus of the people. We believe Heinlenville/John Heinlen would have received even more votes if the greater community were aware of his contributions.

Please consider this decision carefully. The name should reflect the true history of the Heinlenville Chinatown, which is a significant part of San Jose Japantown history. It should reflect the important anti-racist role played by John Heinlen in opposing the anti-Chinese movement in San Jose.

Honorable Mayor Liccardo, members of the City Council, and staff:

Save Our Trails is pleased to support the City of San Jose's 2020 Cycle 5 application for an Active Transportation Program (ATP) Cycle 5 grant from the California Transportation Commission (CTC) for the Five Wounds Trail Project.

Save Our Trails: Connecting Santa Clara County Communities is a California Not-for-Profit Corporation whose mission is *"To promote trails in Santa Clara County for the benefit and enjoyment of all."*

As we said in our 2018 letter of support, having trails that provide off-street access to these important transportation hubs for pedestrians and cyclists is essential to help San Jose meet its goal of reducing vehicular traffic. In addition, it goes without saying, trails are tremendous assets in providing recreational opportunities close to home. The Five Wounds Trail is especially significant in that respect because of its path through densely populated residential neighborhoods.

Save Our Trails supported the City of San Jose's \$34 million ATP Cycle 4 application for the Five Wounds Trail Project. Unfortunately, the 2018 ATP application fell 5 points short of receiving an award.

This past June, the VTA Board approved a \$4.14 million Measure B allocation for the Five Wounds Trail. Thanks to this local contribution, a 2020 ATP Cycle 5 application will be exceptionally positioned for obtaining the final points needed for a state funding award.

This project is part of a larger community trail network in San Jose. At 60 miles, San Jose has one of the nation's largest urban trail networks. Development of this future trail space would connect and serve a historically underresourced community with integrated connections to BART stations and Santa Clara Street Bus Rapid Transit (BRT). This will create seamless connections between our regional trail and regional transit systems.

As strong advocates for extending trails in Santa Clara County, Save Our Trails asks that you support this application for this important and timely project.


