SOURCES RESOLUTION AMENDMENTS TO RECOGNIZE 2020 CORONAVIRUS EMERGENCY SUPPLEMENTAL FUNDING PROGRAM GRANT FUNDS RECEIVED FROM THE U.S.

DEPARTMENT OF JUSTICE

RECOMMENDATION

- (a) Adopt a resolution authorizing the City Manager to execute an Agreement for the 2020 Coronavirus Emergency Supplemental Funding Program Grant award received from the U.S. Department of Justice in the amount of \$865,998.
- (b) Adopt the following 2020-2021 Appropriation Ordinance and Funding Sources Resolution Amendments in the General Fund:
 - (1) Establish a City-Wide Expenses appropriation to the Police Department for the Coronavirus Emergency Supplemental Funding Program Grant 2020 in the amount of \$865,998; and
 - (2) Increase the estimate for Revenue from Federal Government by \$865,998.

OUTCOME

Approval of this recommendation will allow the San José's Police and Fire Departments to use the 2020 Coronavirus Emergency Supplemental Funding Program grant funds to reimburse for overtime costs associated with COVID-19, ensuring minimum staffing levels are maintained in order to continue to provide the San José community with essential emergency services needed during the COVID-19 health emergency.

BACKGROUND

On March 30, 2020, the U.S. Department of Justice released the Coronavirus Emergency Supplemental Funding Program solicitation for fiscal year 2020 formula grant to provide funding to eligible agencies for preventing, preparing for, and responding to the coronavirus. Agencies identified as eligible for funding under the Fiscal Year (FY) 2019 State and Local Edward Byrne Memorial Justice Assistance Grant (JAG) Program are eligible to apply under the 2020 Coronavirus Emergency Supplemental Funding (CESF) Program solicitation. The City has been participating in the Edward Byrne Memorial Justice Assistance Grant (JAG) program since 2005.

On May 27, 2020, the City of San José applied for the CESF Program grant to provide overtime for sworn personnel in the Police and Fire Departments to prevent and respond to the coronavirus. The City was notified of the CESF Program grant award on June 23, 2020.

To provide all-hazard response service to over 1 million residents across more than 200 square miles, the San Jose Fire Department (SJFD) maintains daily minimum staffing levels at 186-line personnel per day. SJFD line personnel resources are deployed from 33 fire stations and include 33 engine companies, nine truck companies, three medic units, one Type 1 Hazardous Materials, one Type 1 Urban Search and Rescue, three Airport Rescue and Fire Fighting vehicles, five battalions, and one EMS Field Coordinator. To maintain daily minimum sworn staffing levels, SJFD requires off-duty personnel to work overtime. SJFD responds to all medical emergency calls in San José, which includes responding to coronavirus positive patients. Emergency medical service calls are essential to responding to coronavirus impacts and all medical calls must be treated as if they are a coronavirus case. While SJFD has implemented medical monitoring for all personnel, directed personal protective equipment (PPE) use, and revised response protocols, the risk of exposure persists and overtime is needed to ensure minimum staffing levels are maintained in order to continue to provide the San José community with the essential emergency services needed during the coronavirus health emergency.

San José Police Department (SJPD) responds to calls for service for more than 1 million residents across the City of San José. SJPD has approximately 1,159 sworn personnel that work to meet the needs of the residents of San José. While the public health emergency has substantially impacted Police Department's operations, Field Patrol is the primary unit associated with monitoring compliance to the County's public health orders and has modified their response to calls for service to address the risks posed by the coronavirus. While SJPD has implemented medical monitoring for all personnel, ensured proper PPE is available and guidance given on proper use of PPE, and has revised response and detainment protocols, the risk of exposure persists and overtime funding is needed to ensure proper staffing levels are maintained and available in order to continue to provide San José residents with essential emergency services needed during the coronavirus health emergency. Essential services may include patrols, responding to calls for service, Emergency Operations Center support, and maintain a minimum level of staffing.

ANALYSIS

The City of San José was awarded the 2020 CESF Program grant in the amount of \$865,998. The grant term is January 20, 2020, through January 19, 2022. This grant will fund overtime for sworn personnel in the Police and Fire Departments to prevent and respond to coronavirus.

The following list provides information on the Spending Plan for the 2020 CESF Program award as approved by the U.S. Department of Justice, as well as administrative costs associated with managing the grant. These estimates are subject to reallocation and/or change over the course of the grant term; however, the total grant amount to the City will remain the same.

- \$433,032 of the funds will be used for sworn backfill overtime for the SJFD in order to maintain daily minimum staffing levels to prevent and respond to the coronavirus.
- \$385,087 of the funds will be used for sworn backfill overtime for the SJPD in order to maintain daily minimum staffing levels to prevent and respond to the coronavirus
- \$47,879 of the funds will be used to fund a portion of a grant analyst position that will manage the grant including distributing the funds, preparation and submission of the financial status reports and programmatic progress reports, preparation of grant modifications, track grant related expenditure; and facilitate procurement.
