SUBJECT: ADOPTION OF APPROPRIATION ORDINANCE AND FUNDING SOURCES RESOLUTION AMENDMENTS IN VARIOUS FUNDS TO REBUDGET FUNDS TO 2020-2021 FOR COMPLETION OF PROJECTS

RECOMMENDATION

- (a) Adopt the following 2020-2021 Appropriation Ordinance and Funding Sources Resolution amendments in the Convention Center Facility District Capital Fund:
 - (1) Increase the Beginning Fund Balance by \$96,000; and
 - (2) Establish the Public Art appropriation to the Office of Economic Development by \$96,000.
- (b) Adopt the following 2020-2021 Appropriation Ordinance and Funding Sources Resolution amendments in the Sewer Service and Use Charge Capital Improvement
 - (1) Increase the Beginning Fund Balance by \$691,000; and
 - (2) Increase the Public Art appropriation to the Office of Economic Development by \$691,000.

OUTCOME

Approval of this memorandum will allow for the timely completion of the projects identified in this memorandum.

BACKGROUND

At the end of each fiscal year, all appropriations lapse and any unspent funds become part of the following year's beginning fund balance. In order to complete projects not completed at the end of the 2019-2020 fiscal year, remaining funds must be re-appropriated, or rebudgeted, to 2020-2021. Usually, such funds are rebudgeted through the 2019-2020 Annual Report scheduled for City Council consideration in October 2020. However, due to the urgency to complete projects, the Administration is recommending to rebudget certain funds at this time.

ANALYSIS

Due to delays in the project identified in this memorandum, a rebudget adjustment will be necessary to complete the projects described below during late summer and early fall.

Public Art - Convention Center Facility District Capital Fund

The rebudget of funds in the amount of \$96,000 is necessary for the Office of Economic Development to complete the public art lighting design and installation component of this project. This early rebudget will secure funds needed to encumber the funds for the construction documentation, lighting and controls purchase, installation, and necessary administrative charges to complete the project by October 2020. The public art project is part of a two-part project, with the first component enhancing the Convention Center parking garage entryway along Market Street with a 3,300-square foot mural (completed) and a lighting component to illuminate the mural and pedestrian pathway in the evening.

Public Art - Sewer Service and Use Charge Capital Improvement Fund

The rebudget of funds in the amount of \$691,000 is necessary for the Office of Economic Development to complete the fabrication and installation of the public art project at the Children's Discovery Museum. This public art project is part of a two-part project that maps, educates, and makes visible to residents and visitors the mostly invisible sanitary sewer and storm sewer systems and how water flows through these systems.

CONCLUSION

The early rebudgets are necessary for the timely completion of the projects identified in this memorandum.

EVALUATION AND FOLLOW-UP

No additional follow up actions with the City Council are expected at this time.

CLIMATE SMART SAN JOSE

The recommendation in this memo has no effect on Climate Smart San José energy, water, or mobility goals.
