Dear City Council:

The Cambrian neighborhood in the vicinity of Leigh High School and Los Gatos Almaden Road has recently been the site of more than three very large (from 30 to 100 vehicles) sideshows. The center of this intersection is blackened from tire marks. The southwest corner of the intersection is Los Gatos jurisdiction while the rest is San Jose. These sideshows are often lasting 25 minutes or so.


We believe that this location is chosen in part because of the jurisdictional conflict and these people know that San Jose will not respond. There is a gas station on one corner (in Los Gatos), the tarmac of which also been used for skidding. The other two north corners have houses and the street is lined with houses to the north.

While Councilperson Foley has been notified, and her aide, Kyle Laverini, informs me that the Southern district commander has been notified, no police have shown up when contacted. This location is less than one quarter mile from where a house was run into by drag racers a few years ago at Anne Way, and a woman seriously injured in her own home. Do we need to wait until more people are crushed while they sit in terror in their own living rooms as reckless drivers take over our neighborhood? Or a gas station goes up in flames?

We residents of District 9 ask for more police protection where it is needed and when it is needed. We support public safety and ask that we be given an equal amount of attention in this regard.

As you are aware, the next earthquake will be coming. What's going to happen without an emergency location such as Reid-Hillview Airport to transport and/or receive supplies?

The protections are currently in place with Reid-Hillview Airport. Removing it would be a complete disaster and an untold human tragedy in an emergency!
