Mayor and Council Members,

As a community member who has been fighting against this car wash, since the beginning, it is important that the Council knows of all of the conversations my neighbors have had in opposition of this project due to its hazardous bringings. Although I do see the petitions on the Agenda for the August 25th meeting, none of the emails, letters, reports, and videos are shown. This is frustrating to see once again. In the previous meeting,

back in 2017, we experienced the same problem that important documents were withheld from the agenda, making a huge difference in the planning department's decision to approve the car wash.

Many of us are in disapproval for this project for several safety reasons. The most concerning is that the car wash is dangerous to all children who attend the three nearby schools on Woodard Road. Each day, community members witness pedestrians constantly cross all three of the property's driveways, and as you can see in the videos Ms. Flynn constantly shows the Council, the drivers are irresponsible. Many of the drivers drive in and out of lanes, are on phones and overall impatiently and recklessly drive during the proposed operation hours. To add a car wash, would be perilous to the community. Unreported accidents often happen several times a week especially around the corner of Woodard Rd. and S. Bascom Ave. If you do not wish to hear the community's words about how hazardous this project is, then I suggest reviewing the traffic and sound reports, recorded by non-biased experienced engineers, who also deemed this proposal to be insufficient. Adding another list of obvious observations to why this car wash is not wanted, it is strictly against the two-hundred feet setback policy for residential uses next to commercial. To my understanding, this specific policy is to protect the residential homes from commercial businesses imposing on the resident's standard of living. I am sure you, too, would not want an extremely noisy car wash in your own backyard, just like the neighbors, who are countlessly opposed, do not want it as well. No wall high enough or big enough will be able to block out the noise from the dryers especially, if the car wash is right behind the homes.

Hopefully, as a concerned individual, you can hear our words and imagine how frustrated we are, as a community, that we are constantly looked over by our elected officials and their staff. All we are asking is to take our consideration into voting NO to this proposed project and ending the loophole so that we do not have to face this problem in the future again.

Then, early in 2019, our community attended the Council Priority setting session, hoping that you would hold to your campaign promise to get rid of the loophole in the Drive Thru uses policy, only to be disappointed that you did not even bring it up, even though it was submitted to the Council Priority Setting Session agenda a year before. This community is now holding its breath, waiting to see if you will honor your campaign promise and support us in not allowing a car wash on this site. This community will remember what decision you make regarding this project.

On another note, this project is poorly planned, and the site is too small for this car wash. One aspect of this project that is a problem is the shared driveway that this site shares with the strip mall containing 4 small businesses. Under the plan for this project, cars getting a car wash will line up along this shared driveway, and will spill onto Bascom, blocking the shared driveway and the unprotected bike lanes and negatively affecting these 4 small businesses. Other problems with this project include that it is 44 feet from the bedroom and living room windows of 16 foreplexes – this

will be a noise and congestion issue for the owners of these businesses as well as tenants that live there and that this car wash is less than 200 feet from Farnham Elementary School, which presents a safety problem for parents, children and community members walking to and from school by this project. Finally, there is the matter of the unprotected bike lanes that run across all of the entrances and exits to Andoil. City staff states that there is no money in the City's budget to protect the bike lanes this year, and will most likely not be any money in next year's budget to protect these bike lanes either.

Planning Director Rosalyn Hughey falsely reports that this car wash is in line with the General Plan policies. That is not true, as this car wash will take away jobs, instead of providing them, and is in violation of the 200 ft. setback for residential uses next to commercial. The way the Andarys have set up this business is that one person will run the gas pumps, the car wash, and the convenience store. They will be removing the automotive repair section, which will cost the mechanics their jobs.

**One thing I noticed on the 8/25 City Council Agenda, item 10.2, under "Letters from the Public, 2 of 2", a letter from Republic Industries addressing the High Rise Incentive Program is listed. This is a mistake, as it in no way addresses the Car Wash. It seems to me that staff is constantly withholding vital information from the Council Members that would drastically change their decision on this matter. I find it extremely unfair for both the community and the Council members, that staff is willing to wait until the last minute (i.e. the day before the meeting) to give said information, especially when they are highly aware that our Council members are extremely busy and will not have the time to review every single piece of information.

I find it very concerning that we are within two days of the council meeting on this topic and we still do not know what our own Council Member's decision is. Not too long ago, when Council Member Foley was out of office, her chief of staff Scott Hughes, advised us that Council Member Foley would need more time to get all the details in order to let us know what her thoughts are. It was fine when it was a month ago however; now the meeting is within a couple of days. Former Council Member, Don Rocha, expressed his opposition to this car wash to the community months before the final hearing, and I would've expected the same for the current Member for District 9. Please see the attached video. It is a video of both school and rush hour traffic shot from the front of my complex on Woodard Road. Farnham School is approximately 200 feet from my front door and Andoil Gas Station. My apartment complex is 44 feet from the proposed car wash, which is in direct violation of the 200 ft.

setback to residential areas, something Rosalyn Hughey should have made clear to you in her report. There are two other elementary schools on Woodard Road. They are St. Francis of Cabrini and a Baptist Bible school, which makes the traffic even worse. When you add three other major projects into the mix, the traffic will be even more horrible than it is now. The other three projects are North 40, South Bascom Avenue Complete Streets, and Cambrian Park Plaza.

The unprotected bike lanes that were just added run down South Bascom Avenue, and across all entrances and exits to Andoil Gas station, making it very dangerous for children and adults to get to Woodard Road where all 3 of these schools are. There is no clear or safe path for pedestrians or cyclists to get around the circumference of Andoil Gas Station. Currently, the strip mall is impeded by Andiol's gas pumps, as they have a shared driveway. Traffic from the gas pumps overflow and spill onto South Bascom Avenue. Oftentimes, you can see people leaving the gas station, making illegal turns onto Woodard Road. We do not have any traffic enforcement to abate this problem. We have at least 2 unreported traffic accidents a week. These children are in grave danger of being hit and/or killed because no one is cited or stopped, or reads the signage.

Furthermore 20 businesses will be directly affected by this car wash. Landlords will have a very difficult time renting out units 44 feet from this proposed car wash. The 4 strip mall businesses will have an even worse time conducting business when the car wash is filling up the shared driveway. Why should one business have privilege over 20 others?

On another note, Andoil gas station will not be adding jobs. They will be taking them away. They are getting rid of their auto repair shop, and will have one person running the convenience store, the Car wash, and the gas pumps. That is not in line with the General Plan. The General Plan asks business owners to bring in jobs, not take them away. Given this information, my hope is that those of you who voted no on this car wash last year vote no on it again. It is only due to a loophole in the car wash drive through policy that was on the priority setting session, ready to be voted on, and was not, that allowed Tony Andary to bring this back. Our Council Member gave us her word during her campaign that she would not vote in favor of this car wash, and that she would fight to get the exemption removed. She did not do either. Also, my neighbors have made it very clear that they do not want this car wash. We have petitions with 1500 signatures on it opposing the car wash. Those signatures include Pam Foley's name.

We have more than 5 car washes in our area alone. We do not need another one. Rosalyn Hughey neglected to tell you in her report that we have reports from both sound and traffic engineers stating that in their expert opinions, that this car wash will create traffic and noise problems for the foreplexes and the schools. Odors from the car wash will be a problem for us. The smoke from the current fires we are experiencing is being pulled in through our air conditioners. My live-in aide has serious asthma, and is having a horrible time with it right now, So nobody, not even OSHA can tell me it is not a problem. Further, our former Council Member, Don Rocha made it clear that the noise from the car wash is not acceptable, and so did our sound engineer. The photos, the reports, the petitions, and the letters we submitted to the Planning Commission are not on the Agenda as attachments. The last time we fought this car wash, we had the same problem. Items were missing or lost.

And finally, I have to tell you that the over \$20,000 that Andary offered me to stop fighting him on this was an insult to my integrity. The lives of these children and my neighbors do not have a price point on them for me. Further, to have Andary contact me again after I refused their offer was even a bigger insult. I could never live my life knowing that I sold my sole at the price of another human being. Please vote no on the car wash, and get rid of the exemption that is allowing Andary to keep bringing this back.

Please confirm receipt of this email, and please let me know how you will be voting on this.

I would like to express my opposition to the car wash proposal on S. Bascom Ave. and Woodard Rd. I believe this car wash is going to be a negative addition to this community. The space is much too small and there are too many threats in the vicinity. For example, as you all have heard countless times, being that we have fought against this permit for years now, that the children going to and from Farnham are endangered, due to the carelessness of these drivers.

We know already that there are a few reported accidents, but if you lived here, and experienced what this community does everyday, you will see that this corner is prone to hit-and-runs constantly, not to mention near misses for pedestrian-vehicle collisions on the weekly. The telephone pole has been knocked down a few times, a woman was killed here not too long ago, and an incident where some reckless driver ran a red light, skidded, and almost hit the unprotected propane tank on the property a year or so back. This place is just too dangerous to have this built here.

On top of that, San Jose's policy entails that any drive-through use must be at least 200 feet away from residential properties. Honorable Mayor and Council Members,

I would like to contact you all to speak my opinion in the matter of the car wash permit proposal on the streets of South Bascom Avenue and Woodard Road.

Just like we did back in 2018, most of us are emailing you to give our opinions on why we do not wish to add a car wash to our community and neighborhood. Certainly, thanks for getting in touch. First of all, let me offer my apologies for the late response, that's my bad. Sorry to hear about the loss of your colleague. I'm familiar with that previous project to block the carwash, so I was surprised when you brought it up, I think it was sold as a project mostly dealing with a new soundwall between the station and the abutting residential. I'm also unfamiliar with how far along this project is, whether it still needs to go to the planning commission or has already been signed off on by the city council.

This is firmly in the jurisdiction of the city of San Jose, so truth be told, there isn't much we'd be able to do from the county side. To that end, I've

cc'ed my counterpart in Councilwoman Pam Foley's office, Michael Lomio, who will be familiar with this project. Thinking through this, Bascom is getting a "complete streets" revamp which will make many upgrades to the infrastructure along Bascom to make it more pedestrian friendly. I would suggest we take an inventory of the safety upgrades near Farnham including crossing lights/bulb outs/medians, and other traffic mitigation that will decrease the speed and mobility of cars along Woodard so that the development doesn't impact school crossing and safety. I am sure you are receiving all of the community's negative commentaries when it comes to this project. For the good of the community and the safety of the children, please hear our words and once again disapprove of this car wash proposal.

It seems to me that staff is constantly withholding vital information from the Council Members that would drastically change their decision on this matter. I find it extremely unfair for both the community and the Council members, that staff is willing to wait until the last minute (i.e. the day before the meeting) to give said information, especially when they are highly aware that our Council members are extremely busy and will not have the time to review every single piece of information.

I find it very concerning that we are within two days of the council meeting on this topic and we still do not know what our own Council Member's decision is. Not too long ago, when Council Member Foley was out of office, her chief of staff Scott Hughes, advised us that Council Member Foley would need more time to get all the details in order to let us know what her thoughts are. It was fine when it was a month ago however; now the meeting is within a couple of days. Former Council Member, Don Rocha, expressed his opposition to this car wash to the community months before the final hearing, and I would've expected the same for the current Member for District 9. As a community member who has been fighting against this car wash, since the beginning, it is important that the Council knows of all of the conversations my neighbors have had in opposition of this project due to its hazardous bringings. Although I do see the petitions on the Agenda for the August 25th meeting, none of the emails, letters, reports, and videos are shown. This is frustrating to see once again. In the previous meeting, back in 2017, we experienced the same problem that important documents were withheld from the agenda, making a huge difference in the planning department's decision to approve the car wash.

Many of us are in disapproval for this project for several safety reasons. The most concerning is that the car wash is dangerous to all children who attend the three nearby schools on Woodard Road. Each day, community members witness pedestrians constantly cross all three of the property's driveways, and as you can see in the videos Ms. Flynn constantly shows the Council, the drivers are irresponsible. Many of the drivers drive in and out of lanes, are on phones and overall impatiently and recklessly drive during the proposed operation hours. To add a car wash, would be perilous to the community. Unreported accidents often happen several times a week especially around the corner of Woodard Rd. and S.Bascom Ave. If you do not wish to hear the community's words about how hazardous this project is, then I suggest reviewing the traffic and sound reports, recorded by non-biased experienced engineers, who also deemed this proposal to be insufficient. Adding another list of obvious observations to why this car wash is not wanted, it is strictly against the two-hundred feet setback policy for residential uses next to commercial. To my understanding, this specific policy is to protect the residential homes from commercial businesses imposing on the resident's standard of living. I am sure you, too, would not want an extremely noisy car wash in your own backyard, just like the neighbors, who are countlessly opposed, do not want it as well. No wall high enough or big enough will be able to block out the noise from the dryers especially, if the car wash is right behind the homes.

Hopefully, as a concerned individual, you can hear our words and imagine how frustrated we are, as a community, that we are constantly looked over by our elected officials and their staff. All we are asking is to take our consideration into voting NO to this proposed project and ending the loophole so that we do not have to face this problem in the future again.

Honorable Mayor and Council,

Council Member Foley, on April 18, 2018, you and I had a Facebook conversation where you stated that there should not be a car wash on the Andoil site. You also, in the same conversation, stated that you signed our petition to get rid of the loophole in the drive-thru uses policy for car washes (we have that petition). This community was grateful to hear these two campaign promises from you.

Then, early in 2019, our community attended the Council Priority setting session, hoping that you would hold to your campaign promise to get rid of the loophole in the Drive Thru uses policy, only to be disappointed that you did not even bring it up, even though it was submitted to the Council Priority Setting Session agenda a year before. This community is now holding its breath, waiting to see if you will honor your campaign promise and support us in not allowing a car wash on this site. This community will remember what decision you make regarding this project.

On another note, this project is poorly planned, and the site is too small for this car wash. One aspect of this project that is a problem is the shared driveway that this site shares with the strip mall containing 4 small businesses. Under the plan for this project, cars getting a car wash will line up along this shared driveway, and will spill onto Bascom, blocking the shared driveway and the unprotected bike lanes and negatively affecting these 4 small businesses. Other problems with this project include that it is 44 feet from the bedroom and living room windows of 16 foreplexes – this will be a noise and congestion issue for the owners of these businesses as well as tenants that live there and that this car wash is less than 200 feet from Farnham Elementary School, which presents a safety problem for parents, children and community members walking to and from school by this project. Finally, there is the matter of the unprotected bike lanes that run across all of the entrances and exits to Andoil. City staff states that there is no money in the City's budget to protect the bike lanes this year, and will most likely not be any money in next year's budget to protect these bike lanes either.

Planning Director Rosalyn Hughey falsely reports that this car wash is in line with the General Plan policies. That is not true, as this car wash will take away jobs, instead of providing them, and is in violation of the 200 ft. setback for residential uses next to commercial. The way the Andarys have set up this business is that one person will run the gas pumps, the car wash, and the convenience store. They will be removing the automotive repair section, which will cost the mechanics their jobs.

**One thing I noticed on the 8/25 City Council Agenda, item 10.2, under "Letters from the Public, 2 of 2", a letter from Republic Industries addressing the High Rise Incentive Program is listed. This is a mistake, as it in no way addresses the Car Wash. But this brings up a question: I know other Community members have written letters to the Mayor and Council opposing this car wash, but the letters as well as reports, video's, and photos do not appear on this agenda. Are they posted on another item by accident? We want to make sure these items are attached to the proper Agenda item, so our community's voices are heard. There are also many letters and documents that we submitted to the Planning Commission that do not appear on this Agenda. Are these items going to be attached to this agenda? We are concerned also that these documents, photos, videos and reports will be attached at the last minute, not giving the Mayor and Council enough time to properly review them. The very first time this project appeared before the Planning Commission, most of the letters and documents we submitted were lost and the Planning Commission did not get to see them. We are concerned that this may be happening again. If these documents, videos, photos, and reports do not appear on the agenda, we will be asking for a deferral to ensure our community's voices are heard.**

Last time this project appeared before the City Council, the City Council in its wisdom saw fit to deny the permit for the car wash. We are asking the City Council to confirm its decision to deny the permit for this car wash.

I can support the staff recommendation with respect to item 10.2 to deny the appeal of the Planning Commission's decision to approve a project known as the Bascom Andoil Car Wash (CP16-035-01), because I believe Cambrian students' safety has been considered and will be protected.

I understand the development of local businesses and appreciate your continued support for the safety of the students and families in the Cambrian School District as they walk to and from school during the regular school year. It is vital that students have safe access to walk to and from school on an appropriate sidewalk with proper crosswalks. As you are very aware, Farnham Elementary School's location is very close to the Bascom Andoil gas station on the corner of Bascom and Woodward. This is the company looking to expand their services to include a car wash. The current sidewalk will be evaporated for students to walk and measures need to be taken to include additional walkways for students and families.
