## **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Breastfeeding Awareness Month was recognized in the month of August and sponsored by Councilmember Arenas. This special event recognizes August as Breastfeeding Awareness Month, which raises awareness to the benefits of breastfeeding and empowers every family that chooses breastfeeding to have all the resources and information they need to succeed.
