Mayor Liccardo and Councilmembers,

Please put Vehicle Abatement back to work at full capacity with full responsibilities to clean up our blighted neighborhoods.

You can see the automated response below that I received from Parking Compliance Supervisor Gina Novello when I questioned her as to why two reports of mine about abandoned vehicles were closed without any action by Vehicle Abatement.

I would really like someone to explain to me the line from her response: "Reduced resources and the COVID-19 operating environment." How were resources reduced? Were they redeployed? Laid-off or furloughed? And what exactly is the "COVID-19 operating environment"? How can Vehicle Abatement personnel contract a virus by placing a self-adhesive orange paper on a vehicle's window? By tapping on their personal computer? By ordering a tow truck? What am I missing here?

Plain old blighted abandoned vehicles aren't good-enough anymore. Vehicles have to be missing parts. Parts on a city-defined list. Filthy vehicles with weeds growing under them covered in spider webs and surrounded by dry leaves are not "extreme blight" and no longer even merit an orange tag, much less a tow. Toss some mattresses

on or around them and maybe you have a shot at having them towed. Better yet, torch them. But as you can see from the attached photos, they're not even being towed in these "enhanced" conditions.

We're being overrun by abandoned vehicles out here on our neighborhood streets. They're torched, dumped on and around, missing parts, and just plain filthy. If the coronavirus is going to be with us for the foreseeable future, we need to get back to work at pre-pandemic levels. The coronavirus is not an excuse to allow the city to fall into a state of disrepair that will take months or longer from which to recover.

Please put Vehicle Abatement back to work at full capacity with full responsibilities to clean up our blighted neighborhoods.

Hello,

In response to the Shelter-in-Place order, on March 17<sup>th</sup> the DOT Parking and Downtown Operations Team temporarily ceased Parking Services including the processing of Vehicle Abatement Service Requests and the issuance of parking citations. Additionally, citation fine payment and adjudication deadlines were extended by 150-days for citations issued on or before March 19, 2020 (currently expires: 8/17/20). Free Parking was also provided at on-street meters, and within the City's downtown surface lots and garages (except City Hall, the City Hall Employee Garages, and the Convention Center which remain closed to the public).

Beginning on June 8<sup>th</sup> limited Parking Services were reintroduced citywide. Parking and Traffic Control Officers (PTCOs) began conducting systematic vehicle patrols throughout San José. During these patrols PTCOs are proactively driving every public street within city identifying and addressing only safety and health concerns related to parking. Reduced resources and the COVID-19 operating environment continue to impact the level of services provided by the Parking Compliance Unit. Current Parking Compliance services are as follows:

### VEHICLE ABATEMENT

PTCOs will not be able to respond to requests submitted via email, online or through the San José 311 mobile app. Additionally, please understand that PTCOs are also not able to tow vehicles that appear to be lived in.

PTCOs are focusing on proactively addressing clearly non-operational vehicles, and vehicles that pose a health, or safety concern, or are contributing to extreme blight. By patrolling every city street, we are making better and more equitable use of staff resources while removing more vehicles. Only vehicles that meet Non-Operational or Health/Safety/Blight criteria (see below) are being towed at this time.

### WHAT DOES NON-OPERATIONAL MEAN?

Vehicles are considered non-operational ONLY if they are:

- Missing a windshield, or
- Missing the driver's seat, or
- Missing two or more wheels, or
- Missing steering wheel, or
- Missing an engine, or
- Have any damage substantial enough that the vehicle is rendered completely immobile.

# WHAT DO WE MEAN BY "HEALTH AND SAFETY CONCERN OR CONTRIBUTING TO EXTREME BLIGHT"?

Vehicles are considered a safety concern or contributing to extreme blight if they are:

- On jacks / blocks, or
- Missing or have shattered windows, or
- Vandalized / Graffiti (non-commercial vehicle), or
- With significantly flat tires, or
- Attracting illegal dumping activities.

### WARNINGS & CITATIONS

PTCOs will not be able to respond to individual requests for enforcement submitted via email, online or through the San José 311 mobile app.

The Parking Compliance Unit has been conducting proactive safety violation patrols citywide, touching every city street, and issuing citation warnings for identified safety violations, since June 22nd. Since initiating proactive patrols, the PCU has issued over 4,000 citation warnings throughout the city for safety related violations such as blocking curb ramps, bike lanes, sidewalks, red curbs and no-parking.

With the return of paid parking in the downtown on August 3rd, enforcement activities are being expanded to include meter related violations. This expansion of enforcement services will supplement current safety violation patrols.

Parking compliance activities are being phased in thoughtfully, addressing potential health and safety concerns while remaining sensitive to our community's economic concerns, as well as, public health order protocols.





For the past 7.5 years, South Bay Clean Creeks Coalition SBCCC has been working to reclaim our local Waterways. This year we will eclipse a significant milestone, 1,000,000 lbs. of trash cleared from in and around our creeks. At past meetings I have raised the question, "Are we winning the War on trash".

With the onset of COVID-19, the trash situation has become even more dire with hundreds of our unhoused now living adjacent to our living creeks with much of their trash piling up in the creeks and stream banks. It would be one thing if this problem was isolated only to City property but with the upcoming winter storms much of this trash will be pushed downstream exiting into the Bay and subsequently the Pacific Ocean. This is an ecological disaster.

What have learned from our past reclamation work? With support from CDFW Game Wardens and City Park Rangers we were able to keep Los Gatos Creek relatively encampment free for several years and saw limited resources required to sustain. We had hoped that with the reintroduction of SJPD that patrols could help to move the trash problem ahead. But SJPD scope of work doesn't currently address the environmental impact of trash linked to these encampments.

We are not alone is this struggle to find adequate housing for our unhoused. Recently, Sacramento implemented an ordinance which prevents camping within 50' of the levees & Stockton has also worked to prevent camps along their streams. The City of San Jose is a leader on many initiatives but we need to look to our neighboring cities and adopt programs that are working. The answer is not to increase capacity of existing programs if we are not willing to address the root causes. Why can't we achieve both; housing for all and clean healthy creeks?

# Subject: Neighborhood on Tuers Rd, along the CoYote Creek Park: Between Capital Express Way and Yerbabuena Rd.

Mayor Sam Liccardo and San Jose City Managers & Officials :

I am reaching out to each one of you in despair because our neighborhood is inundated with homeless encampments at Coyote Creek Park and ilegal dumping right in front of our lawn, backyard, sidewalks, street intersections and main roads.

My neighbors and I have also cleaned many times human feces from the sidewalks because our children, elders and pets run the risks of getting contaminated. We have also recovered many needles that are thrown into the main road on Tuers. If anyone would have been stuck by the needles, they run the risk of contracting numerous diseases. The people who are primarily at risk are our children and youth as sometimes they are outside playing.

There are men and woman from the encampments who have hijacked the Coyote Creek Park to used it for their drinking habits. They sit by the entrance to the park and drink beer openly for hours as if the Coyote Creek Park was their personal property. Under these circumstances no local residents can't go into the park. We have contacted many times to the appropriate departments for homeless outreach programs and ilegal dumping but there is never a permanent solution.

Once the ilegal dumping is cleaned, the ilegal dumping continues with no regards to the signs that says "NO ILEGAL DUMPING" The main reason why there is so much ilegal dumping in our neighborhood is because the people living in the homeless encampments at Coyote Creek Park throw their garbages around the perimeters

of the park.

At night some of them walk around in the suburb and they were recorded in our home security cámaras urinating and defecating in the street. No one feels safe at night to even walk their pets on Tuers Road. One of the neighbors tells the atrocious and chilling story when her daughter was raped while ridding her bike through the Coyote Creek Park.

we have observed suspicious activities happening late at night around 1 AM on Tuers Rd and Alvernaz Dr. Some nights we see two high end cars with tinted windows parked along the shoulder of Coyote Creek Park. The two men from the two cars interacts casually with four men who lives in the creek. After a while they seem to exchange something. Since we can't get too close to see what these people are doing late at night in a residential neighborhood-we could only imagine what it looks obvious to us.

We had called the San Jose Police department and asked the dispatcher to please send a police officer to patrol the area. We gave as much details as possible and our information in case if the police officer wanted to get in touch with us. However, the police officer never arrived or contacted us. We believe and trust our police officers. We need them to patrol our neighborhood. We used to see them patrol few months back but we are not sure Why they haven't been as responsive as they used.

Our neighborhood is not Willow Glen or Palo Alto but we can be like them or even better.

We feel that our neighborhood hasn't been given the priority that it needs. We want A CHANGE! We want our neighborhood to be CLEAN and SAFE!

We want to build a good example for our CHILDREN. We need to ERRADICATE HOMELESS ENCAMPMENTS from The Coyote Creek Park.

1. Our neighborhood is requesting to please have all of the homeless encampments PERMANENTLY removed from the Coyote Creek Park and from it's surroundings. I was already told that because of tracing of covid19 infection that homeless encampments were not being removed at the moment. Nevertheless, this is not an excuse to not relocate them to an interim location where they can have access to a bathroom, shower, hand washing station, food...etc.

2. Complete restoration of the Coyote Creek Park and it's beautiful nature. Installation of new fences all around the park with multiple gate entrances for the local residents and anyone who respectfully appreciates and wants to enjoy the park.

As mentioned already, right now the Coyote Creek Park is off limits to local residents because it's not safe with all of the current homeless encampments.

Did I mention that one man living in the creek has a dog and sometimes the dog wonders around the park unsupervised. I am afraid that someone walking by can get bit by this dog.

3. Installation of signs saying "Encampments are not Allow at Coyote Creek Park" "If anyone needs immediate housing assistance Or any other assistance then the number or information should be displayed here ..." this way the person is given the opportunity to hopefully make the right choice.

4. We need more post lights installed along Tuers Rd.

5. Can there be a park ranger or someone always responsable for always keeping the Coyote Creek park clean and safe?

5. We need the Police officers to Patrol the area regularly on daily basis, especially late at night. Please do not cut back on our police officers. Our community needs them. We feel safer when we see them patrolling our streets.


