SUBJECT: APPROVAL OF THE DOMESTIC VIOLENCE AWARENESS MONTH ROTUNDA LIGHTING ON OCTOBER 1-7, 2020 AND COMMUNITY EVENT SPONSORED BY COUNCIL DISTRICT 5 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

# **RECOMMENDATION**

- 1. Approve October 2020 as Domestic Violence Awareness Month to be recognized as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
- 3. Place the item on Tuesday, September 22, 2020, Council Agenda for action.

## **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution No. 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds. Domestic Violence Awareness Month Event will be held on Thursday, October 1, 2020, at City Hall and sponsored by Councilmember Carrasco. The Rotunda will be lit purple to highlight the importance of eliminating Domestic Violence in our community and the impact on all of us from October 1-October 7th. The event is free and open to the public.

## **ANALYSIS**

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising
