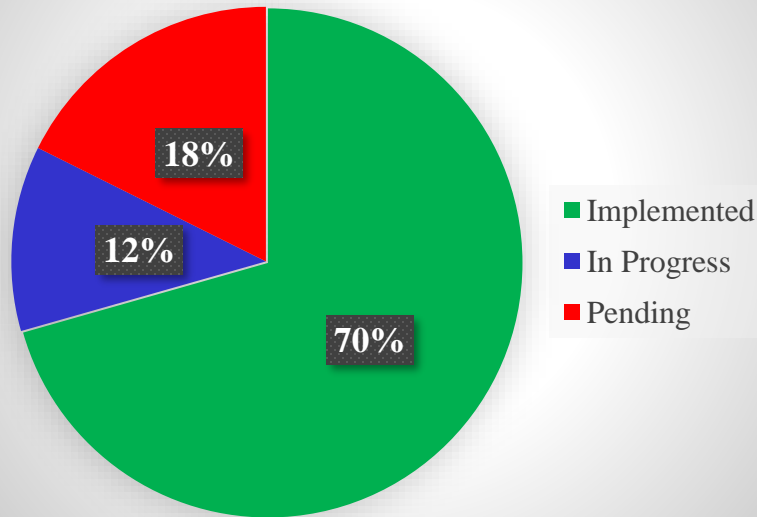

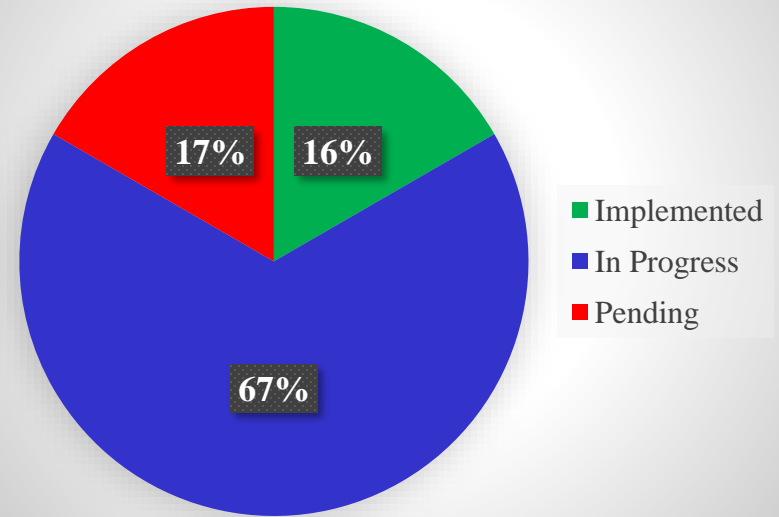

Recent Work Items of Note

- Special Victims Unit (SVU)
 - The creation of SVU has provided more time for proactive investigations:
 - Six Human Trafficking operations
 - 20 Child Pornography arrests
 - Developing new proactive strategies
- School Age Intervention Training:
 - At the LAST PSFSS report this was on COVID-19 hold.
 - Since then it has been redesigned as an online course scheduled to begin delivery next week.



Recent Work Items of Note

- Substandard Housing Study:
 - Funding has been allocated (\$150,000)
 - The RFP language has evolved around what data sets are available to study and how much analysis can be reasonably expected at this price point.
 - Examine geographic sex assault distribution by zip code, crime type, age of victim, and relationship to offender.
 - Document new or persistent challenges in handling S.A. cases.
 - Identify ages groups and communities for targeted outreach.
 - Understand how relationships between police, survivors, and prosecutors are evolving.
 - Examine the role of community characteristics in developing data driven decisions to present to stakeholders.
 - Identify best practices and emerging trends.
