REPORTS TO COMMITTEE

(1) Verbal Report on Economic Development Activities.

OED Public Information Manager, Elisabeth Handler presented highlights of the latest edition of the SJ Economy E newsletter, including: news of the City Council's passage of the electronic billboards measure, which is now resulting in an RFP process to advertisers interested in getting their digital signage seen on some of our City owned buildings downtown. This includes the Convention Center, the Museum of Art and the Center for the Performing Arts. These will enliven downtown, especially at night. The Diridon Station Area community engagement process continues apace, with a series of community events held in August and September. First was the August kickoff at the Arena Green wher Google shared their framework for the community to have a close look at, and the City' OED set up its own information table, where it responded to question from participants. Second was the Village Fest in District 7 at the Village Oaks Shopping Center in September. There was also Viva Calle yesterday where we had information table set up too, with many people coming by. Olympus heralded its 40th year in its San José headquarters, which is now houses its international service center for surgical technologies. They've outgrown the building where they started with 200 employees, and one shift to the current three shifts and over 800 employees; they will move into their new building in 2020. On the manufacturing side, we had a successful roundtable that was hosted by the Silicon Valley manufacturing roundtable folks, which brought together a panel to discuss the implications of financial planning for corporate health at Prospect Silicon Valley. The founder and owner of Knox Cookie Bar recently disclosed how his financial analysis uncovered an entirely new business opportunity previously unknown. He's in the process of contracting with Safeway. There's an upcoming student housing downtown opening in 2020; and finally, Skate Martinez has designed some amazing crosswalks at the intersection of San Salvador and South First Street, working collaboratively with the City's Office of Cultural Affairs, The Department of Transportation and The Downtown Association.
