(2) Vision Zero Action Plan Update. (Transportation / Police)

Transportation Director John Ristow, Vision Zero Program Manager Jesse Mintz-Roth, Transportation Safety, Operations, and Parking Deputy Director Lily Lim-Tsao, Police Captain Jason Dwyer, and Police Department Bureau of Field Operations Deputy Chief David Tindall, gave a presentation, and responded to questions.

<u>Public Comments</u>: Offering comments on Vision Zero Action Plan Update were: Kirsten Smith, Nikita Sinha, William Kirkpatrick, John Cordes, (Silicon Valley Bicycle Coalition); Gina Leblanc, Diane Solomon, Paul Marshall, Tessa Woodmansee, Roland Lebrun Marshall Woodmansee, Blair Beekman, and Brandon Alvarado.

<u>Action</u>: Upon motion by Councilmember Raul Peralez to move approval, seconded by Councilmember Maya Esparza, and carried unanimously, the Vision Zero Action Plan Update, was accepted, and cross-referenced to the full Council Meeting in January 2020 for action, with the Police Department directed to return with a plan or strategy to increase staffing levels. (3) **City-Generated Tow Services Delivery Model Report.** (Planning, Building and Code Enforcement)

Planning, Building and Code Enforcement Deputy Director Rachel Roberts, Finance Deputy Director Jennifer Cheng, and Police Department Captain Dave Santos, gave a presentation, and responded to questions.

Staff is also directed to continue to refine the service model and the pilot program approach, and return to the Transportation and Environment Committee (T&E) in February 2020 with the final plan for implementation.
