I was nominated by the Board of the Japantown Business Association to represent our community. We are a small but active contributor to the Downtown Parking Fund. Japantown is one of San Jose's most historic districts and one of the U.S.'s last three remaining Japantowns; parking and infrastructure is critically important to our neighborhood's sustainability as a retail, arts, and historic district.

I am either a sole proprietor, partner or manager at three businesses in the Japantown, a district affected by DPB policies. I reside in Japantown and witness, on a daily basis and in great intimate detail, how parking and transportation policies affect the businesses, nonprofits, and residents of our neighborhood. My family owns and operates Roy's Station, a coffee shop in the heart of Japantown, and are deeply rooted in the Japantown community. Our efforts in promoting bone marrow drives, disaster relief efforts (the bake sale for Japan after the 2011 Tohoku earthquake and tsunami raised over \$15K), crime awareness and personal safety, and the overall efforts to grow the neighborhood have been a continual effort for almost a decade. My family is personally responsible for almost 100% of the maintenance and upkeep of the center of Japantown. My father sweeps our business district's two blocks every day, 7 days a week. I personally clean all business windows from 3rd to 6th Street on Jackson 2x annually. We maintain the cleanliness of the street's historical monuments and benches, and sidewalks. We also handle graffiti abatement on a daily basis. We fully understand how every facet of Japantown -- from cleanliness. to friendliness, to community involvement, to traffic, to pedestrian safety -- affects how people feel when they come into this neighborhood. My company, Rasteroids Design, was founded in 2000 and is comprised of only my brother (programmer) and myself (design), so all these design projects were coordinated, developed, and executed entirely by myself. My design clients include San Jose Taiko, the San Jose Museum of Quilts & Textiles, Empire Seven Studios, the San Jose Stage, Ron Muriera, Cellista (musician Freya Seeburger), JAMsj, the San Jose Buddhist Church Betsuin, Wesley United Methodist Church, several local tattoo studios and freelance artists. My brother and I also personally developed (at our own expense), a neighborhood community website to benefit all businesses and organizations within the Japantown neighborhood (http://www.jtown.org). When the City of San Jose, Department of Transportation and DPB were analyzing whether to double Japantown's parking meter rates in 2018 with the SmartMeter implementation, I created a SurveyMonkey survey to assess how business owners, residents and visitors of Japantown felt about it; in about a month's time, we collected more than 500 answers from respondents. This information provided background for the DPB's recommendation and decisions made by the City Council. I feel it is crucial to assess strategies with analytics, ROI and a true representation of a community's needs/wants.
