#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Filipino American Heritage Month is recognized in the month of October and sponsored by Councilmember Esparza. This special event recognizes October as Filipino American History Month, which highlights the rich history and contributions of Filipino Americans from the first documented arrival of Filipinos on the North American continent on October 18, 1587.
