#### **RECOMMENDATION**

## BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Sikh American Awareness & Appreciation Month will be recognized on Tuesday, November 3, 2020 and sponsored by Councilmember Arenas. The City of San Jose and District 8 are home to the largest Sikh Gurdwara in North America and Sikh Americans have enriched our communities as professionals, friends, and neighbors. This special event is an opportunity to honor the contributions of the Sikh-American Community to the City of San José.

# ANALYSIS
