Dear Mayor Liccardo and Councilmembers:

Every ten years since the City of San Jose first moved to district elections, our community goes through the critically important process of redistricting. This process ensures that the voices and votes of every community member and every neighborhood can be heard equally in the life of our City. Since the decisions we make in this process will impact us for the next decade, it is vitally important that the process be conducted in an inclusive and transparent way that welcomes all voices to have a say as we redraw district lines, especially those of our underrepresented communities of color and working families.

We encourage the City Council to adopt the proposal by Councilmembers Jimenez, Peralez, Carrasco, Esparza and Arenas to ensure greater participation so that every voice is heard in this important process and in our local democracy. Their memo refers a series of reforms to the Board of Fair Campaign and Political Practices to consider with a goal of increasing participation among underrepresented and underserved communities, promoting equity in political voice, and preventing conflicts of interests in appointments.

Decisions on the structure of our Redistricting Process should be vetted by the San Jose community, not jammed ahead by the Mayor, his campaign treasurer, and an outside organization. We remain troubled by the attempt to game the system and rework this process with no community outreach and without going through the appropriate process of review by the Board of Fair Campaign and Political Practices, a body created to review and recommend fair and ethical practices relating to our City's political process.

Furthermore, the decision by the Mayor to rush this decision forward, months ahead of the Redistricting Commission doing its work and on the eve of such an important election smells like a power grab, and an effort to silence the voices of community members.

At a time when community participation is growing increasingly challenging for low income families and communities of color, it is important we focus on creating an inclusive process, inviting more community members to participate in more ways. Whether it's language access, internet access, challenging work schedules or care commitments that make attending public hearings untenable, or the inability to leave home due to COVID-19 risks, all too many people in our community face hurdles in participating in public policy decisions that limit the ways they can participate. The memos by Councilmembers Jimenez, Peralez, Carrasco, Esparza and Arenas supports this by hosting meetings in each Council District, by making meetings language accessible, and by accommodating caregivers.

For many San Jose residents, especially among immigrants and communities of color, the way they choose to engage with decisions before the City of San Jose is through their local neighborhood organization or a trusted community-based organization. As we envision the redistricting process, we need a process that leverages the trust and the strength of these institutions and invites more community members to participate, not one that shuts the door in their faces. This is why we believe it is vitally important to not ban all forms of ex-parte communication, per Mayor Liccardo's proposal. Civil right organizations, community-based nonprofits and neighborhood associations representing communities of interest should absolutely not be prohibited from communicating with staff or members of the Commission if we wish to promote dialogue and accountability on this complicated, and at time technical set of decisions. Real community participation requires more than two minutes of public comment. Per the Councilmembers and staff or Commission members outside of public hearings, but we should not ban such communications out-right if we wish to encourage accountability, transparency and equity.

Lastly, we agree with Councilmembers Jimenez, Peralez, Carrasco, Esparza and Arenas' concern about the creation of an independent Commission. The example of the California Redistricting Commission highlights the fundamental flaws of relying solely on an appointed commission to address issues of equity. Latinos continue to be significantly underrepresented on the Commission statewide and in the other major City with such a commission locally, Long Beach. There is no evidence to suggest such a commission would produce any more equitable of an outcome in San Jose, given our recent challenges in promoting equity in our policymaking boards, like the Planning Commission.

We urge City leaders to carefully consider the needs and the voices of those communities that have historically been excluded, both here in San José and across our nation, and set forward a Redistricting process that will provide all of our communities and residents the confidence that their voices are being heard—and matter.
