## RESOLUTION NO.

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN JOSE APPROVING APPLICATION TO THE COUNTY OF SANTA CLARA'S HISTORIC GRANT PROGRAM BY LA RAZA HISTORICAL SOCIETY OF SANTA CLARA VALLEY FOR THE PRESERVATION PROJECT OF CHIECHI HOUSE AT HISTORY PARK SAN JOSE, TO ACCEPT THE GRANT IF AWARDED, AND TO DELEGATE AUTHORITY TO THE CITY MANAGER TO SIGN THE GRANT APPLICATION, GRANT AGREEMENT AND TO AUTHORIZE THE CITY MANAGER TO EXECUTE ALL RELATED DOCUMENTS

WHEREAS, the County of Santa Clara ("County") has established the Historic Grant Program to acknowledge and celebrate untold perspectives of underrepresented communities within Santa Clara County ("Grant Program"); and

WHEREAS, the County requires that the property on which the grant-funded project is located be continually used for public purposes for a minimum of 20 years for Capital Improvement projects and a minimum of 10 years for Non-Capital Improvement projects, subject to constitutional or charter limits on appropriations for future years, and be open to all Santa Clara County residents on a non-discriminatory basis; and

WHEREAS, the County requires that the property owner will allow for, or provide for, the continued maintenance of the project, and

WHEREAS, La Raza Historical Society of Santa Clara Valley would like to submit an application to the County's Grant Program to preserve and restore the Chiechi House, located at 635 Phelan Avenue, and

WHEREAS, the City of San José ("Owner") has reviewed the grant application; and

**WHEREAS**, the application for this Project complies with the requirements of the Grant Program, and if funds are awarded, the Owner will execute the grant agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN JOSE THAT that the City of San José hereby makes the following determinations:

- 1. The City of San José has reviewed the grant application and, if the project receives funding,
- 2. The City of San José will provide for continual public use on a non-discriminatory basis for 20 years for the following proposed Capital Improvement project: Preservation of the Chiechi House at San Jose History Park.
- 3. The City Manager is hereby delegated authority to sign the grant application, grant agreement on the Owner's behalf and execute all related documents.

BE IT FURTHER RESOLVED that the City of San José hereby approves of the La Raza Historical Society of Santa Clara Valley's application for County's Historic Grant Program funds for the Chiechi House at History Park San Jose.
