SUBJECT: APPROVAL OF THE FREE HOLIDAY TREE GIVEAWAY SPONSORED BY COUNCIL DISTRICT 3 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

- 1. Approve the Free Holiday Tree Giveaway event scheduled on December 5, 2020 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses, or community groups to support the event.
- 3. Place the item on the December 1, 2020 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Free Holiday Tree Giveaway event will be held on Saturday, December 5, 2020 at the Roosevelt Community Center and will be sponsored by Councilmember Raul Peralez, San Jose FireFighters, Local #230 and Jay Paul Company. This special event will provide families with the opportunity to register to receive a free Christmas tree to take home and enjoy for the holidays. The event is free and open to the public.
