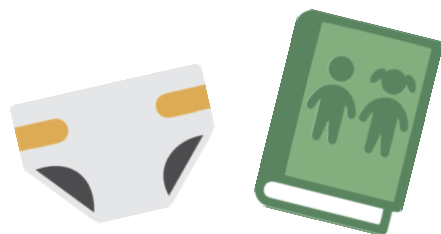

# Increase and Preserve Affordable Housing Opportunities

🏠 **337** households received Rental Assistance and Case Management (38% female head of household)

🏠 Second Street Studios & Villas on the Park



# Respond to Homelessness

- 🏠 **1,208** individuals received street outreach engagement, case management and rapid response
- 🏠 **1,559** homeless persons received overnight shelter
- 🏠 **47** families assisted with homelessness prevention services





## Strengthen Neighborhoods – Public Services

- 🏠 **82,523** people received COVID-related food assistance (5,000 households w/children)
- 🏠 **61** business owners assisted
- 🏠 **324** participants received leadership training (127 female head of household)

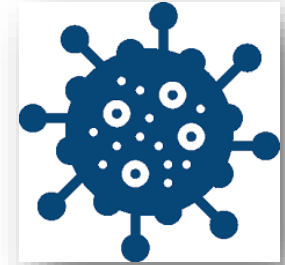
