Please describe your experience in serving on a Commission or Board.

I found serving on the Downtown Parking Board to be compelling, valuable, and ultimately of great importance to decisions the City Council made over the years. Many of those decisions resulted in safety, attractiveness, and quantity and quality of parking in the downtown core. The greatest benefit was working with a diverse group of people whose commitment and ideas merged and resulted in great contributions. The same point could be made for all panels I have served on.

I feel a high level of seriousness toward bettering the community - and that has driven me to the businesses and non-profit organizations that I have served. My commitment toward housing for all led me to join SCCAOR; my love of community led to bettering The Alameda District; my love of San Jose's history led to serving History San Jose and also to specializing in historic and vintage homes and neighborhoods. All of these activities have resulted in engagement with the Council and Mayor on multiple occasions.

What is your understanding of the purpose of the Commission?

The immediate purpose of the Commission is to study the City's governance structure and determine, through community input and consultation, if a strong mayor system would be more appropriate and beneficial to the City. In addition, the question of whether mayoral elections should be moved to coincide with presidential elections is a candidate for recommendation. Beyond these two initiatives, I would imagine the Commission would remain in service to review other questions of Charter that are raised. The fact that 2 members of each Council District are designated suggests this would be a commission well-informed by the greater community.

Please list three issues facing the City that you feel the Commission should address.

1. The issue of replacing our current "weak mayor" system with a 'strong mayor" system, given the size and complexity of City department interactions and governing authorities. 2. The question of the value of moving mayoral elections to the presidential cycle, specifically if this move would engage a greater participation of the city-wide population. At the same time, consider how this might affect Council seat elections. 3. The commission should continue its work on the Charter, receiving recommendations from the City and the community on how to better govern, and review current language and understanding so the Charter is updated.

I contributed to the drafting of policies that addressed guideline requirements, and that resolved local procedural problems to the extent feasible.

I am an attorney, trained in finding resources to become informed on any given topic.
