Dear Mayor Liccardo, Vice Mayor Jones, and City Council Members Jimenez, Peralez, Diep, Carrasco, Davis, Esparza, Arenas, Foley, and Khamis,

We at Mothers Out Front Silicon Valley (formerly South Bay) **share the League of Women's Voters' and others' concerns** about the *Potential Ballot Measure to Amend the City Charter*. Although our primary area of focus is climate justice, we recognize that we will not be able to advocate effectively for this cause--nor any of the other vital issues we face--if our government is not fully representational, transparent, equitable, and inclusive.

We applaud Mayor Liccardo for listening to the community and proposing to delay the placement of a strong mayor proposal on the ballot until 2022. It's vital that this process include robust community input, especially from underrepresented portions of our community, and a thorough consideration of the complex pros and cons of various city governance structures.

We agree with the League of Women Voters that:

- Proposing a major change to our city's governance structure should not be done hastily and needs to be preceded by an Independent Charter Review Commission.
- Given the tremendous financial strains the City is experiencing, expensive ballot measures should not be placed on the ballot unless truly necessary.
- Ballot measures should not contain multiple subjects. Each of these three proposals should be considered separately, not intertwined.
- The City Council should use its own authority to strengthen campaign finance transparency and disclosure laws rather than put these issues on a ballot measure.

Therefore, we **agree with Mayor Liccardo's proposal to delay** a charter revision proposal until November 2022, and we appreciate Vice Mayor Jones's and Councilmembers Esparza and Carrasco's thoughtful recommendations. **We support Councilmember Arenas's memo specifying a requirement for significant community engagement to determine if and how our government structure should change. We urge you to adopt Councilmember Arenas's recommendations as, in our judgment, they combine the best ideas of the previous ones.**

Thank you in advance for ensuring a representational, fair, inclusive, and transparent process for making such a consequential decision as changing our governance structure.
