

# MINUTES OF THE PUBLIC SAFETY, FINANCE AND STRATEGIC SUPPORT COMMITTEE AND MEETING OF THE WHOLE

# 1. First Quarter Financial Reports for Fiscal Year 2020-2021. (Finance)

Deputy Director of Finance, Rick Bruneau responded to questions from Councilmember Sergio Jimenez regarding outstanding debts. He indicated that the statute of limitations and other factors prevent the City from retrieving these funds.

<u>Action</u>: Upon motion by Councilmember Sergio Jimenez, seconded by Vice Mayor Chappie Jones and carried unanimously, the First Quarter Financial Reports for Fiscal Year 2020-2021 were accepted for the following programs: (a) Debt Management

(b) Investment Management (c) Revenue Management, with the First Quarter Financial Reports for Fiscal Year 2020-2021 referred to the December 8, 2020, City Council Meeting for acceptance, and forwarding recommendation to the City Council for the December 8, 2020 Council Meeting to adopt a resolution authorizing the Director of Finance to write-off uncollectible debts in an amount up to \$2,779,960.60. (5-0.)

### REPORTS TO COMMITTEE

# 1. Police Department Operations and Performance Bi-Monthly Status Report. (Police)

Lieutenant Steve Donohue and Acting Assistant Chief Dave Tindall provided the presentation.

<u>Public Comments</u>: (1) Caller "5140" questioned the need for more traffic officers. (2) Blair Beekman discussed data collection, surveillance, long-term community harmony and advocated for demilitarization.

Lieutenant Donohue and the Assistant Chief responded to extensive questions from the Committee.

Councilmember Sylvia Arenas requested a bigger picture on sexual assaults, particularly for victims from 0-14 years of age, from March through the end of the year. She asked that these statistics be included in the year-end report. Additionally, asking that frequency of calls repeatedly made to particular residences be identified, urged a greater degree of outreach to these survivors. Acting Assistant Chief Dave Tindall spoke to the outreach efforts made.

<u>Action</u>: Upon motion by Councilmember Sylvia Arenas, seconded by Councilmember Magdalena Carrasco and carried unanimously, the Police Department Operations and Performance Bi-Monthly Status Report was accepted. (5-0.)

Councilmember Sergio Jimenez left the meeting at 3:45 p.m.

# 2. Domestic Violence Prevention and Awareness Annual Report. (Police)

Lieutenant Robert Lang and YMCA representatives Lindsey Mansfield, Associate Director of Services, and Cynthia Melchor, Community Support Manager provided a presentation.

Staff responded to questions from the Committee.

<u>Public Comments</u>: (1) Blair Beekman spoke on community issues in the light of the current pandemic. (2) Caller "5140" expressed budgetary concerns.

## 3. Personal Care Business Compliance Initiative Follow-Up Report. (Police)

Lieutenant Paul Messier provided the presentation and responded to questions.

Action: Upon motion by Councilmember Magdalena Carrasco, seconded by Councilmember Raul Peralez and carried unanimously, the follow-up report on the Personal Care Business Compliance Initiative with respect to the status of illicit massage businesses was accepted. (3-0-2. Absent: Jimenez, Jones.)

Discussion continued following the vote, with Lt. Paul Messier answering questions.

- 1. Caller "5140" offered criticism of the police department.
- 2. Blair spoke to need for federal funding during the COVID crisis and spoke to federal issues.
