RECOMMENDATION

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Holiday Grab and Go was held on Wednesday, December 16, 2020 at Leyva Middle School, Holly Oak School, Montgomery School, Katherine Smith School, & DJ Meyer School and sponsored by Councilmember Arenas. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
