Diversity is a cache of resources that can provide creative, effective and thoughtful solutions and approaches to many of the challenges our world faces. This Commission should utilize San Jose's diversity in order to address the inequity in representation, lack of access to services and resources, and divestment experienced by San Jose's communities of color. The second issue facing San Jose stems from being the heart of the Bay Area - one of the fastest growing regions in California - which has contributed to the imbalance of economic success for residents. Many residents in San Jose face no-win decisions too often, at times deciding whether to have food on the table or a roof over their head. It is essential that every government body recognize and strive to balance the area's wealth with the working poor that comprise the infrastructure of our communities, apply a robust racial equity lens to every decision, and ensure recommendations and policies serve the needs of all residents now and continue to benefit them in the future. The third issue facing San Jose is the lack of investment in public education. Economic shifts and dislocations mean community colleges have a critical role in educating and training displaced workers with limited resources. This Commission can establish district boundaries that unite communities and elevate the needs of those communities, including the voices of those that are yearning for an investment in public education.
