



Concentration of SARS-CoV-2 in San José wastewater:









Regional Stay at Home Order


- Individuals are required to stay home except to conduct essential activities
- Gatherings with other households is not allowed, including outdoors
- Worship and political expression are permitted outdoors
- Guidance related to schools remain in effect and unchanged

Closed indoors AND outdoors:

- Cardrooms
- Personal care services
- Playgrounds
- Museums, zoos, and aquariums
- Movie theaters
- Family entertainment centers

Closed indoors AND outdoors:


- On-site dining service at restaurants/wineries/bars (takeout and delivery allowed)
- Limited services businesses (e.g. dog groomers, landscapers)
- Amusement parks
- Smoking lounges
- Campgrounds for overnight stays

Closed indoors, but open outdoors

- Gyms, including group fitness classes
- Recreational facilities
- Swimming pools

Open indoors and outdoors:

- All retail (20% capacity indoors)
- Shopping centers (20% capacity indoors)
- Essential infrastructure (20% capacity indoors)
- Healthcare facilities, including non-urgent procedures
- Hotels and lodging facilities, for essential travel or quarantining purposes only



Overview of Allocation Process



The County's allocation of vaccine from the State has two components:

- 1 Doses directly from manufacturers for vaccinations at County-operated hospitals and other sites
- 2 Certain multi-county healthcare providers, such as Kaiser, will receive vaccine doses directly from manufacturers as directed by the State





H.R. 133 Highlights – COVID Relief Items

\$2.3 trillion package, includes:

- **Coronavirus Supplemental**
- **Annual omnibus appropriations**

Covid Programs	Funding
Direct Stimulus Checks - \$600 for individuals, \$1,200 per couples, \$600 per each child dependent, mixed immigration status families	\$166 B
Unemployment Insurance - \$300 per week through March 2021, extension of PUA, up to 50 weeks	\$120 B
Small Business Assistance – Second round of PPP, funding for CDFIs and MDIs, SBA extended debt relief payments, enhanced SBA lending programs	\$284 B for PPP \$20 B for EIDL \$15 B for Venue Operators
Food – 15% increase in SNAP benefits, food bank, senior nutrition	\$13.5 B
Broadband – Funding to low-income households for \$50 discount plus subsidized devices, funding to Minority Serving Institutions, telehealth, broadband maps	\$7 B
Childcare – Childcare Development Block Grant Program, includes funding for family payments	\$10 B
Transit	\$14 B

H.R. 133 – Direct Funding Programs

City of San Jose is eligible for a share of the following programs:

- Treasury Department Emergency Rental Assistance Program (\$25 billion)
- Airport Coronavirus Response Grant Program (\$2 billion)

*No new direct, flexible local funding.
However, CRF extension to
December 31, 2021.*



Treasury Department Emergency Rental Assistance

-
- \$25 billion program, distributed to jurisdictions with populations more than 200,000. Formula similar to Coronavirus Relief Fund.
 - Funds are available until December 31, 2021
 - Beginning in September 2021, the Treasury Department is authorized to take back any unobligated funds to redistribute.
 - Administrative costs capped at 10% of the award.



Treasury Department Emergency Rental Assistance

What can funds be used for?

- Back and forward rent, utility payments, other housing expenses.
- Assistance for 12 months, with the option for the City to extend another 3 months.
 - Required to assist with back rent first before paying forward rent.
 - Forward rent can only be provided for 3 months, but households can reapply after the 3 months.
 - The City can pay the landlord or utility directly.



Treasury Department Emergency Rental Assistance

Who qualifies?

1. Households with one or more individuals that qualify for unemployment benefits or can attest in writing a reduction in income or financial hardship due to pandemic,
 2. Demonstrate risk of homelessness, and
 3. Has household income below 80% AMI with priority for households below 50% AMI or those who have been unemployed for 90 days.
- Not for people who are receiving other Federal housing assistance.
 - **Next Steps**
 - **1/8 Paperwork submitted to Treasury**

Eviction Moratorium Status Update



- H.R. 133 includes an extension of the CDC Eviction Moratorium to January 31, 2021.
- State of California's eviction moratorium is more stringent than Federal moratorium.
- AB 15 (Chiu) - Would extend AB 3088 protections to December 31, 2021.
 - City supports, hearing week of January 11, 2021
 - Urgency legislation, would take effect immediately
 - Governor called on the legislature to extend AB 3088 (Chiu), which expires January 31, 2021.

Stimulus Package: Small Business Relief

Paycheck Protection Program (\$284 billion)

- Provides \$284 billion for the Paycheck Protection Program (PPP),
- Extends the PPP through March 31, 2021.
- *Applications being accepted through approved lenders beginning:*
 - *Jan. 11 – through participating CDFI's/low-income-community lenders ONLY*
 - *Jan. 13 – through ALL participating SBA lenders*

Economic Injury Disaster Program (EIDL) Grant Program

- \$20 billion for EIDL Advance grant program

Grants for Shuttered Venue Operators (\$15 Billion)

- \$15 billion for Small Business Administration (SBA) grants up to \$10 million to live venues, independent movie theaters, and cultural institutions.
