To the City Council, City of San Jose CA. Fr: Minority Business Consortium L.L.C. Re: Disparity Study

The Minority Business Consortium (MBC), Silicon Valley's foremost "Diversity and Inclusion in Contracting" firm, writes this letter in support of the City of San Jose engaging in a "Disparity Study".

In California, disparity studies generally focus on economic issues involving M/WBEs competing for local and state government agency contracts. An economic disparity study will provide government agencies analysis and insight to help determine if access to government contracts is unfairly being denied to minority and women owned businesses. The results and outcome of the study will help these local or state governments assess the need for change in procurement, contracting and purchasing policies and practices and allow them to develop procedural changes or new programs to create greater equity. MBC is proud to have worked on the most recent local disparity study in the County of Santa Clara and strengthened the development and implementation of race/gender neutral diversity and inclusion construction contracting programs.

Background:

Proposition 209, which prohibits preferential treatment in public employment, education, or contracting, on the basis of race, gender, or national origin, was adopted by California voters in November 1996. Since then, government entities in California have eliminated or modified their contracting affirmative action programs, in response to real or perceived limitations imposed by the new law. However, there have been surprisingly few legal decisions regarding the parameters of Proposition 209, leaving some uncertainty about the range of measures available to government entities to ensure diversity, promote competitiveness, and avoid discrimination in public contracting.

With the defeat of Proposition 16 in California, a proposition to overturn Prop 209, the accepted legal remedy is to begin with a Disparity Study to assess whether there are implicit or explicit barriers in contracting opportunities for minority and women owned businesses. This tool assists in determining, through extensive research, whether there is discrimination in government procurement and contracting processes.

Given the fragility of small businesses impacted by COVID-19, the importance of an economic disparity study for the City of San Jose is more important than ever. It would assess the need, identify barriers and provide a strategy to address any potential inequities in the city's contracting procedures and processes.
