

As an architect by training, and a policy wonk by nature, I've always been fascinated by the impact design and planning can have on people. This impact often extends far beyond the boundaries of a given project or policy; adjacencies, and how lines on a map or drawing can tangibly impact the lives of people should be at the heart of all such policymaking. As a bicycle commuter to Diridon Station, and a Caltrain commuter to San Francisco, for eleven years prior to the pandemic, I crossed between San Jose Council Districts every day, and saw how the built environment on one side of a line can have a substantial impact on those on the other side. I will soon be terming out after having the honor of serving on the City's Historic Landmarks Commission for eight years, six of which as the Chair. I feel that my passion for the built environment and reasoned, appropriate policy has served me well on the Commission, and I hope that the same can be said of its impact on the City of San Jose. The pace and scope of change taking place within the City is all but unprecedented; like the pace of technology - I'll refrain from citing Moore's Law, because it realistically died a decade or more ago - this dynamic process has outgrown the lines drawn a decade ago. The economic, social, and physical realities of 2020 need to be properly incorporated into the redistricting process.
