Please describe your experience in serving on a Commission or Board.

I have not served on a commission or board at the San Jose City or Santa Clara County level, but have served on multiple boards, committees, and task forces/working groups, at a local and national level, in both the private and public sectors, and for a non-profit organization. I have held both positions of leadership (president, secretary, treasurer, etc.) and general membership on those committees and boards. I am familiar with the workings of a Board and what is governed by Robert's Rules of Order, California Corporation and Civil Codes (if applicable), and board or committee charters, etc. I have read through San Jose Municipal Code, and understand the conduct of a city-level Board or Commission. In particular, as a Board President, I have set the agendas, conducted meetings and Town Halls of the membership. I have been responsible for guiding the decisions of the Board, and then the implementation of those decisions. As a Board officer, I fulfilled the duties for that specific role on the committee. For example, as a Board Secretary, producing the minutes, and communications for the Board. I have actually helped to set up some committees, for which I participated in writing up the charter. I have organized and participated in committee/board events, focused on soliciting stakeholder (legislators/policymakers/management/etc,) and membership input, to achieve the goals of the committee/board. Most recently, at the local level, I am the President of the Board of Directors for the Paseo Plaza Homeowners Association, which is the community in which i live in San Jose. I have served in that capacity for almost five years. I am a member of the Board of Directors of NorCal SCI, Inc., which is the governing board for a San Francisco Bay Area non-profit that focuses on support of the spinal cord injury community. This is a board that is necessary to meet the requirements for guidance of a non-profit and its funds expenditures. In the past, in Washington, DC, I served on multiple interagency (across all federal agencies, e.g. Department of the Treasury, State Department, NASA, Environmental Protection Agency, Small Business Administration, etc.) working groups and task forces that were charged with sorting through various issues or initiatives that the federal government planned to address or undertake. These had the intent of setting federal policy in the area that the group was focused on. We generally did this working with the Office of Management and Budget and/or the Office of Science & Technology Policy, at the White House. In this capacity, the members of the task force were often drafting policy and working with the various stakeholders to solicit and incorporate their input. Further, we were recommending to the executive branch, the final form of that policy to adopt, and what may have to be legislated by Congress.

I have extensive knowledge of the workings of government, at a federal, state and local level. I have written legislation that has become federal law, and written policy that has been adopted, also at the federal government level. I have worked with high level policy makers, executives, and legislators, in setting policy or law, in an advisory capacity, by analyzing the relevant data, synthesizing that data into recommendations on actionable policy or legislation, and then preparing the documentation necessary for them to call upon to make their decisions. The redistricting effort will be similar where the commission will have to look at the current census data, geographic maps, the diverse make up (ethnic, income-basis, transient populations, etc.) of the various neighborhoods, and collect stakeholder input on the possible changes or impacts of those changes, to synthesize it into a recommended set of actions by the City Council, resulting in the redistricting ordinance. Additionally, I have spent much of my career managing large programs and projects (some a billion dollars or more), which relied on working across many geographically differing areas and diverse types of people, then being sensitive to their unique needs, while trying to achieve project success. There could be a lot of competing needs for settling on a set of equal population districts, at the same time assuring that the citizens in that district are well represented. and served. I have also spent considerable time as a strategic planner and analyst, where I have had to synthesize large amounts of data into cohesive conclusions and actionable steps, resulting in a written plan for the organization. A plan that could be communicated and understood by stakeholders, both inside and outside the organization. I generally have a big picture view, and can deal with many moving parts at the same time, and can organize those parts, into an understandable framework. This has also helped me to communicate complex problems in a simple and understandable/actionable manner. Once the Commission finishes it work, it will be key to synthesize all the data collected into a clearly communicated plan, for which the Council can take action on, and report out to the stakeholders.

What is your understanding of the purpose of the Commission?

The purpose of this Commission is to make recommendations to the City Council on the local redistricting of San Jose, following the 2020 Census. Redistricting is the process of redrawing district boundaries to guarantee equal voter representation, which is done after each ten-year census. The recommendations of this Committee are to inform the San Jose redistricting ordinance, that will provide the new city districts until the next census.

Please list three issues facing the City that you feel the Commission should address.

Ideally, a redistricting would result in all citizens having a fair representation in choosing their local representatives, and a voice in other matters of governing. The issues, or more so complicating factors, facing the City, that the Commission should take into account, are listed below. Note that in my view, there are more than three, due to the size and diverse nature of San Jose: 1) The ethnic diversity of San Jose, while not an issue in itself, adds complexity to redistricting, and assuring that each voter regardless of race or ethnicity, has fair representation and an equal opportunity voice in the voting process. Redistricting, if not done properly can suppress certain groups from that fair representation. 2) The income inequities that exist, generally, by neighborhood, in San Jose, have to be considered to assure that no barriers exist for low-income citizens from having their fair representation and voting ability for their needs. 3) How to infuse homeless into the redistricting equation, knowing both the possible transient nature of their living, and other aspects that complicate determining what district to assign them to, and to also assure they also have a fair representation. 4) How to deal with undocumented immigrants and their numbers that may have been counted in the census, since San Jose is a "sanctuary city" and depending on how the federal government settled on their inclusion, will possibly have to be factored. Albeit they cannot vote, they are possibly included in the census numbers. 5) The large geographic diversity and spread of San Jose, which encompasses both rural, industrial, and urban areas, which tend to have very different needs from their elected officials. 6) What gets "broken" in a redistricting, and how to deal with that. For example, if a neighborhood was part of a district, but will be included in a new district, what this does to funding or how the schools are impacted. 7) The huge growth of San Jose, across the past decade, which will result in some current districts having a greater population than in the past, and how to re-balance with this in consideration. To also have a look to the future, knowing where San Jose growth will continue or stall. For San Jose there is probably little political party gerrymandering to protect from, since, in general there is uniformity, across most of the San Francisco Bay Area on political leanings. But this should always be taken into account.

My belief is that every citizen should have equal representation, and this coupled with my policy background and knowledge, make me a solid candidate to serve in this capacity. Mineta San Jose Int'l Airport is losing major airlines to SFO - namely United and JetBlue. We need to double down on our relationships with airlines that have and continue to use SJC as a hub for their flights, like Alaska and American Airlines. Secondly, SJC (and the larger municipality) is also lacking hugely in transit opportunities - I recommend building an above-ground tram from SJC to Diridon, and as a Managing Partner developing eight acres less than 2 miles from the airport (Wyndham Garden San Jose Airport), I can help to facilitate its construction expeditiously. Thirdly, SJC is lacking in lounges and outlets for business travelers to enjoy during their layovers. This is critical to attract upscale and international travelers, and "The Club" is not cutting it! As a hotelier by industry and an expert in hospitality, I can assist in engaging and enticing major vendors like American Express into investing in the largest airport in Silicon Valley proper.

I would engage with the conflicted party to understand the issue and what their vision of an optimal resolution is. Describe recent San José arts activities you have participated in during the last twelve months (up to five activities) and what drew you to attend?

1) HERO Tent Community Forum regarding the Thomas Fallon Statue in San Jose and Mayor Sam Liccardo's failure to keep his promise to host a public convening moderated by historian Al Camarillo, promising to announce a date within the week and absolutely no follow-up more than one month later. He loves to venerate "democratic institutions," while dismissing his own constituency as thugs/vandals in the same breath. This forum was held in partnership with the Chicano Moratorium, Black Outreach, and other community members and educators. I was compelled to participate because I have watched our municipal leaders repeatedly stumble and fail to serve the needs of our most vulnerable populations well before and especially during this pandemic. The Vision of HERO (Human Empowerment Radical Optimism) Tent is to fuel and sustain human rights activism in the Bay Area. Their objectives include ensuring protests continue viably throughout the Bay Area, providing an environment where protestors can feel that they can continue their civil rights activism, assisting the drive for systemic change, and to help unite human rights organizations throughout the Bay Area. Activism and artistry go hand-in-hand. 2) United We Roll: Hosted by SJ Roll Call (formerly SJ Skate Night): One of my favorite socially-distanced pandemic adventures has been participating in local rollouts (on my electric tricycle, built for Burning Man) and hearing the righteously indignant voices of activists and leaders in the San Jose community. We bike/skate/scoot/blade/etc. through neighborhoods transformed by murals and brightened by chalk art lining the sidewalks. These nights are filled with the laughter of children and the cackling of rebellious teenagers, and the air is giddy with the excitement of revolution. These "skate nights through San Jose" are something truly special and catalyzes a sense of freedom & hope; I encourage everyone to participate if they can. 3) VOTECHELLA: Volunteered with the Safe Return Team and the John R. Lewis Equity Campaign with this voter registration drive with music, food/swag giveaways. As an avid concert-goer, it was nice to help facilitate a voter drive next to a beautiful stack of enormous speakers. Music is a treasure, and I have been innovating ways to bring live music experiences back to the Bay Area (especially digital ones) to support audio-visual producers and stagehands like Radiant Atmospheres and Know:Audio. I have been voting since I was 18, and am registered as an American Independent. With the passing of Prop 18, I feel compelled to engage with high school seniors and engaging as many young voters in the democratic process. It disappoints me that a voter turnout of 66.7% in our presidential election is the highest in 120 years, and we can certainly use music/art to grow this number even further. 4) Solution Bay Area + Radical Neighbors food drive at St. James Park: helped hand out hygiene kits and masks, and helped to collect blanket/pillow/camping equipment and other donations from local community members and residents. St. James Park is just down the street from our North San Jose business, and we have been donating blankets and pillows there for many years. I know that there is currently a "Revitalization Strategy" for St. James Park in the works, and I am curious to know more about what the City of San Jose plans for those sheltering in the park currently. Will they be further displaced, packed up and sent to adjacent municipalities like Milpitas or Morgan Hill? I am also interested to see what models of public-private partnership are drafted for ongoing stewardship of the park (so that I can bring them to Rincon South Park adjacent to our parcel in North San Jose), and to learn more about the tools/systems utilized for making the park a safe, fun and desired location that complements the local neighborhood as well as the broader San José community.

Describe the ways in which you believe the arts bring value to the general community.

I experienced the value of art viscerally and empirically when I drove myself out to Burning Man in 2015 alone and turned 21 in the Black Rock Desert on September 1st. I recognized, for the first time ever, the importance of art and the spaces that facilitate its creation. San Jose is smothered in suburbian angst, and is long overdue for the creative explosion festering in a variety of forms in its motley of suburbs. The San Jose underground scene is alive and well, and happens behind closed doors in invite-only spaces. We need to create public spaces that foster self-expression and civic engagement. Consider Paint The Void, a project launched by a number of my friends & colleagues in Oakland to paint the plywood boards covering hundreds of storefronts throughout the City due to COVID-19 and BLM protests. The initiative invigorated otherwise daunting urban streets with color, life, and perspective. This endeavor was such a success that the City of San Francisco recently launched its own version of the same in mid-November 2020. The City of San Jose should be next, and Living Color San Jose (a women-powered 501(c)(3)) is already spearheading similar initiatives. This is just one example. I have watched low-income families continue to be displaced further and further from San Jose in order to find affordably priced units, to Morgan Hill & Gilroy, or as far as Tracy and Concord. Our failure to provide effective public transportation options and fix the ever-worsening traffic in the Bay Area creates twelve-hour workdays for these workers including the 2-3 hours it takes to commute to and from their workplace. It's unsustainable, and more and more families are slipping below the poverty line.


