## **RECOMMENDATION**

Adopt the prior recommendations and appointments articulated in Mayor's January 12, 2021 memorandum, with the following modifications:

1. Apprise the council of the Mayor's appointments for the Rules Committee, selecting Councilmember Cohen, Councilmember Davis, Councilmember Esparza, Vice Mayor Jones, and Councilmember Perez. Vice Mayor Jones will serve as Chair, and Councilmember Perez will serve as Vice Chair.
2. Approve appointment of Councilmember Carrasco to the Valley Transportation Authority board, in place of Councilmember Arenas.
3. Approve appointment of Councilmember Carrasco to the Police Athletic League Board, in place of Councilmember Esparza.
4. Approve the appointment of Councilmember Arenas to serve as Council liaison to the Human Services Commission. Direct Staff to inquire with the members of that Commission to consider whether to rename that body in a manner that more clearly reflects its responsibilities to advise the Council on issues most relevant to members of our community with disabilities.
5. Decline to amend Council Resolution 79367, maintaining the City's existing allocation of appointment responsibility.

## **DISCUSSION**

In our last meeting, Councilmember Arenas respectfully requested not to take on the VTA assignment given to her, Councilmember Carrasco will continue to serve on VTA.

In light of concerns raised by Council regarding the balance on the Rules and Open Government Committee, the Mayor selected Councilmember Peralez to serve in his place.

Councilmember Esparza's appointment to the Rules and Open Government Committee created a scheduling conflict with her position on the Police Activity League Board Councilmember Carrasco will be appointed to the Police Activity League Board in her place as it is in her district.

We decline to amend Council Resolution 79367, allocating appointment authority. Even if amended, if the appointments of this memorandum are approved by Council, any change to that Resolution would not affect any of this Council's or Mayor's appointments. We leave that question for future Councils and Mayors to consider.
