I consider serving on a commission or board an honor, a privilege, and civic duty. My family greatly benefited from the generosity of nonprofit organization, civic engagement clubs, and government programs. Very early on, I learned the value of paying forward. I have an extensive history of public service and volunteerism since I was in high school. My first board position was over twenty years ago, when I was elected to serve on a section leadership position for the American Public Health Association as a public health graduate student. Since then, I continue to serve on boards and commissions, including holding leadership roles, dedicated to promoting health parity, advancing human relations, and promoting social justice. Serving on the County of Santa Clara's Human Relations (now known as Human Rights) Commission, including two terms as Chair, afforded me the opportunity to learn parliamentary procedures, but more importantly to serve as bridge between constituents and the government. Currently, I'm serving in my last term on City of San Jose's Council Appointment Advisory Commission, assisted with citywide outreach activities, refine process for vetting candidates, and currently serve as Vice-Chair.

For nearly 20 years, I dedicated my career to promoting health parity, improving the health status of underserved (often marginalized) communities, and addressing stigmatized health issues. My greatest strengths include 1) transform setbacks and barriers into opportunities; 2) galvanize and elevate community voice to improve institutional structures; 3) translate theoretical frameworks and policies into practice that empowers community; and 4) bring diverse stakeholders together that have unique and competing agendas while facilitating them towards a mutually beneficial common goal.

What is your understanding of the purpose of the Commission?

The purpose of CAAC is to make commission appointment recommendations to City Council for its consideration. There are specific commissions that are under the purview of CAAC. The recommendations are based on application reviews, interviews, and respectful deliberation among the commissioners. The bulk of appointments occur twice a year. In between, commissioners convene to addressing standing business items such as officer elections, annual calendar adoption, and review scope of work. As needed, the commission convene for special or ad hoc issues.

1. RACIAL & SOCIAL EQUITY: Develop an inclusive process that promotes opportunity for candidates representing the rich diversity of City of San Jose to apply, interview, and successfully appointed to the various commissions. 2. CIVIC ENGAGMENT: Explore the opportunity for CAAC commissioners to serve as civic engagement ambassadors for the City of San Jose by participating at district level and citywide outreach/recruitment events; in partnership with the Offices of Racial Equity and City Clerk assess the current composition of all the commissions collectively and develop recommendations to address gaps in representation. 3. GOVERNMENT TRANSPARENCY: Starting with its own commission, CAAC develop, document, and institutionalize standards of practice that will be reviewed every 2-3 years to ensure relevant or requires modification. Ensure method to transfer knowledge and practices during each transition.
