Dear City Council:

In March, I was out of work. I applied for unemployment. It took forever to get any response. COVID was just starting to hit the US. Stores and businesses were closing. I was fearful that I wouldn't be able to find work. I couldn't wait and so I snapped up the opportunity to work at Lucky's grocery store. They were hiring.

Working 8 hour days lifting heavy milk crates, twisting to put cans on shelves, interacting with customers, pushing carts, cleaning out the bloody butcher block, bending down on my knees to wipe up a broken ketchup jar, and more..... it's tough work. And for this 53-year body, there hasn't been a day where I don't come home aching tired.

Over the past months, COVID-19, wearing a mask all day long was just something that I had to get used to. Many customers have bitterly complained about it, though. Some have shouted at me other co-workers and refused to comply with County restrictions. As the 2020 elections rolled along, these confrontations continued. Trump and his campaign was partially fueling this stuff. I just shrugged at it all and kept my nose down and just did my work.

COVID became a real thing in my life when after the Christmas holidays, which were an extremely busy time in the store, I started seeing co-workers disappear. Where did Jen go? What happened to James? Did Carlos get sick? No one was saying anything. Management was silent. Last week Ashlyn came to work, finally. She told me it was COVID. She got it bad. Headache, sever fever, loss of smell and taste, body aches, and more.

I realized this was no joke. And certainly, it was not a fake new hoax. COVID was in my work place. My co-workers got it and were quarantined!

I don't take for granted the daily health check, anymore. And all the precautions we take to distance, wash hands, wear gloves, sanitize shopping carts, and wipe down surfaces are all very important to protect my health and the health of my co-workers, and to protect the public. I am starting to double mask after listening to a Dr Fauci interview yesterday.

Never have I thought of my work as anything special. In fact, I have kinda felt ashamed for having to take a grocery worker job. It pays \$15 an hour. It's a wage that is not sustainable. I'm glad my wife and son have steady jobs to keep our household afloat. But I have realized that my job is to help feed people. The hundreds of people coming into the store, especially around the holidays, really drove that point home to me. I realized that my health and the health of my co-workers impacts a lot of others. Large stores like Lucky's are critical in the food supply chain. My small task of bagging groceries, is a really big thing.

So my question to you, City Council members is this...... what is my labor worth?

I put myself in harms way. I am asked to mask up and be in an environment where exposure is a possibility. It's really only a matter time that I'm exposed to COVID. I work in an environment that is closed in. I take pride in the fact that I am an essential worker. Do I deserve more while big corporations are making money hand over fist on the back of my labor? Yes, I do.

I urge you to support the City of San Jose ordinance to pay essential workers the extra \$5 for our labor, and for my labor.

I came to this country with little knowledge of the language and with my main skills being cooking and cleaning. For the last 30 years I have cleaned home owners' homes, I have served food to students in universities, and I have raised two young men who are college educated and my absolute pride. I have prayed to God fervently that they would take every opportunity to prepare and progress themselves.

My son Miguel works in a local Safeway in the meat department to pay his way through school. He found a passion for butcher, food safety and general service during his time at Safeway. I celebrated his interest. There is value in every person's labor, whether higher education was required in their profession or not.

Then the pandemic came. Every day as I watched my son pack his lunch and cover his face with two masks, my prayers became different. Since the beginning of the COVID-19 pandemic, grocery workers have continued to report to work and serve their communities, despite the ongoing hazards and danger of being exposed to the novel coronavirus. The pandemic is far from over and the health threats that grocery workers face are just as real now as they were when this crisis began.

With the appearance of a new strain of coronavirus the risk posed to grocery workers is even higher. In a recent VOX article Tom Frieden, the former director of the Centers for Disease Control, stated: "Shopping for five minutes in the grocery store is a lot better — six times better — than shopping for 30 minutes". Grocery workers do not have the option to be in the stores for five minutes. Grocery workers cannot choose to work from home-- they must come to work do their jobs, which involves substantial interaction with customers.

The number of COVID-19 clusters within the grocery industry across the state continues to rise significantly. The health threat that these grocery workers face cannot be overstated. The local grocery workers union, UFCW Local 5, reports that over 1,200 grocery workers in their ranks have tested positive with COVID-19, and members of their union have been hospitalized or lost their life to this coronavirus. This is what the union reports, imagine what the non-union grocery workers are facing. In addition, there have been highly publicized outbreaks at local grocery stores across the region.

When grocery workers signed up to do their job, they did not sign up to take on the risks they now face and because of this the undersigned organizations support the efforts requiring their employers to provide "hazard pay" of an additional \$5/hr as long as the City is at or above a coronavirus risk level of moderate under the State Health orders.

It is a shame that all the top retail food companies but for one, Lucky/Save Mart, stopped paying their workers "hazard pay" in June to pursuit profits. A recent Brookings Institute Study indicates that the retail food companies have earned record-breaking profits during the pandemic and this increase in profit has not transferred to workers. Since the beginning of the pandemic Lucky/Save Mart has been giving additional pay to their workers. The actions of Lucky/Save Mart show it is only the lack of will and true appreciation of their workers that prevents large companies from putting some of their profits back into the pockets of workers.

Dear Members of the San Jose City Council:



On behalf of the California Retailers Association (CRA), inclusive of our grocery and retail pharmacy members, we respectfully urge the Council to refrain from passing a mandated a wage increase, especially in the absence of a complete economic impact analysis on the effects such a mandate would have on essential businesses, and subsequently, our local communities.

The California Retailers Association is the only statewide trade association representing all segments of the retail industry including general merchandise, department stores, mass merchandisers, fast food restaurants, convenience stores, supermarkets and grocery stores, chain drug, and specialty retail such as auto, vision, jewelry, hardware and home stores. CRA works on behalf of California's retail industry, which currently operates over 164,200 stores and employs around 2,776,000 people—nearly one fifth of California's total employment.

A mandated pay increase beyond what retail employers can tolerate without raising prices or cutting workforce hours will hurt both consumers and our hardworking employees. This is the last thing our members want to do in the middle of the COVID-19 pandemic and economic crisis. A number of our members are already offering substantial increases in hourly pay and employee bonuses in recognition of the essential work these employees are providing. An inflexible, one-size-fits-all approach risks increasing the cost of food, grocery, and retail pharmacy drugs and will disproportionately impact those in our communities who are already bearing the brunt of this pandemic. All of this comes on top of the recent minimum wage increase. This is why we would request an economic study before the Council mandates a substantial pay increase.

We request that this motion be amended to include an economic study prior to any consideration of an increase in pay.

Dear Local Elected Leaders:

Our coalition of local grocers, community advocates, and business leaders strongly urge our region's local elected leaders to undertake a complete economic impact assessment to fully understand the consequences of any proposed mandatory grocery worker wage-increase ordinances before moving forward.

Local grocery stores are committed to paying competitive wages and benefits to their employees. Since the start of the COVID-19 pandemic, grocers have invested significantly in infrastructure and enhanced safety protocols to protect frontline essential workers and shoppers, as well as to provide incentive pay, bonuses and additional health benefits for grocery workers.

The proposed emergency pay mandates ignore this commitment and ongoing efforts, and would have significant, negative impacts at the worst possible time.

The proposed increases in grocery worker pay would substantially increase the cost of food and groceries for our region's residents and families by an estimated \$400 per year for a family of four. Higher grocery costs would hurt Californians at a time they are already struggling to put food on the table – and would be especially harmful to low-income, people of color and disadvantaged communities.

According to a recent Public Policy Institute of California survey, 29% of Bay Area residents earning less than \$40,000 per year have had trouble paying some kind of bill as a result of COVID-19. Forty-seven percent (47%) of the region's low-income residents report cutting back on food. Increasing the cost of groceries and other essentials would only compound these already-concerning statistics.

Extra pay mandates could also harm the very workers they are intended to help. Higher costs could force grocers to reduce the number of workers, available hours, and even store locations.

In addition, extra pay mandates could make it more difficult for many grocers to stay afloat, especially independent grocers, small markets, ethnic grocers and grocery stores in disadvantaged communities already struggling to keep their doors open. Most grocers operate with thin margins, even during the pandemic. **Shutting down grocery stores will result in**

increased food insecurity and food deserts, especially in low-income and disadvantaged neighborhoods.

These ordinances are rushed and not adequately researched. We urge our local elected leaders to pause the vote on any local extra pay ordinance until you complete a full analysis of the costs, impacts on local families and our community, and input from local businesses.

Additional, extra pay mandates will not make grocery workers any safer.
