Thanks to government money as well as private philanthropic funds, the number of folks we have served, although not nearly enough, is remarkable. The agencies that have stepped up to join in partnership serves as a reminder to me of what an amazing community we have, and why I am proud to be a part of it.

In spite of everyone's best efforts, families still remain in crisis and as each new month begins, the cycle continues. We are seeing nearly 100 calls per day just in our office alone, in urgent need of assistance.
