BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Dental Health Awareness Month will be held in the month of February and sponsored by Councilmember Arenas. This special event recognizes February as Dental Health Awareness Month, which brings together dental professionals, healthcare providers, and educators to promote the importance of dental care and oral health for children, adults, and families.
