The Guadalupe River Park Conservancy submits this letter in **support** of the Mayor's Budget Message for Fiscal Year 2021-2022, and we ask the City Council to approve and direct the City Manager to submit a balanced budget for Fiscal Year 2021-2022, guided by the policy direction outlined in the Mayor's March Budget Message.

The City Manager is directed to continue programmatic consolidation under a single manager solely focused on ridding our City of blight. The City should maintain those innovative programs that appear to be effective—including but not limited to SJ Bridge,BeautifySJ Neighborhood

March Budget Messagefor Fiscal Year 2021-2022March 8, 2021Page 11Beautification Grants, Murals for Graffiti Hot Spots, Cash for Trash, Neighborhood Dumpster Days and others, while streamlining others to reduce duplication of management. The City Manager is further directed to return with a Manager's Budget Addendum that clearly articulates the management consolidation strategy, the source of funding for the increased service levels necessary to effectively clean our City—including the use of federal relief funds, if allowable—and options for continuing investment over at least the next two years."
