BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

The Walnut Mobile Home Park Dumpster Day will take place on April 10, 2021 at 4320 Monterey Rd, San Jose, CA 95111. Councilmember Jimenez is the sponsor of this event. This special event will allow residents to discard unwanted items legally and safely while helping keep illegal dumping off our City streets. The event is free and open to the public.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Jimenez will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1).
