SUBJECT: APPROVAL OF STRESS AWARENESS MONTH COMMUNITY EVENT SPONSORED BY COUNCIL DISTRICT 8 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

RECOMMENDATION

- 1. Approve April 2021 as Stress Awareness Month to be recognized by the City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses or community groups to support the event.
- 3. Place the item on the Tuesday, April 13, 2021 Council Agenda for action.

BACKGROUND

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

Stress Awareness Month will be recognized on Tuesday, April 13, 2021 and sponsored by Councilmember Arenas. This special event recognizes April 2021 as Stress Awareness Month, which is an annual campaign to increase public awareness about the causes and cures for our modern stress epidemic. Stress levels have increased since the COVID-19 pandemic and feelings of disconnection, uncertainty, and a worrying loss of control has intensified stress levels causing physical and mental health concerns. Since 1992, Stress Awareness Month has been a national, cooperative effort to inform people about the dangers of stress, successful coping strategies, and harmful misconceptions about stress that are prevalent in our society The event is free and open to the public, and will follow all appropriate local public health rules, including requiring masks and social distancing.

ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events.
