## **RECOMMENDATION**

- 1. Approve April 2021 as National Child Abuse Prevention Month to be recognized by the City Council on Tuesday, April 20, 2021 as a City Council sponsored Special Event and approve the expenditure of funds.
- 2. Approve and accept donations from various individuals, businesses or community groups to support the event.
- 3. Place the item on the Tuesday, April 20, 2021 Council Agenda for action.

#### **BACKGROUND**

On February 1, 2005, the City Council adopted Resolution 72517 which requires Councilmembers to submit a memorandum to the Rules Committee regarding proposed City Council sponsored Special Events and the proposed use of any funds.

National Child Abuse Awareness Month will be recognized on April 20, 2021 and sponsored by Councilmember Arenas. This special event recognizes April 2021 as National Child Abuse Prevention Month, which is an annual campaign to raise public awareness about the importance of communities working together to help families thrive and prevent child maltreatment. This year's National Child Abuse Awareness and Prevention Month's theme is "Thriving Children and Families: Prevention With Purpose" to promote positive child and family well-being.
