

MINUTES OF THE JOINT MEETING OF THE RULES AND OPEN GOVERNMENT COMMITTEE AND COMMITTEE OF THE WHOLE

SAN JOSE, CALIFORNIA

WEDNESDAY, MARCH 10, 2021

Consistent with the California Governor's Executive Order No. N-29-20, Resolution No. 79450 from the City of San José and the Santa Clara County Health Officer's March 16, 2020 Shelter in Place Order, the City Council meeting was not physically open to the public. Public comments were accepted via eComment, email, by phone/Webinar or online.

The Council meeting was teleconferenced from remote locations and convened at 1:30 p.m.

A. City Council (City Clerk)

<u>Public Comments</u>: (1) Paul Soto discussed historical inequities and procedural issues, with agenda items not being available in a timely matter, that the government is playing with citizenry, denying them the right to participate. He added that Items 4.1 and 4.2 should be taken as separate issues and should have a time certain. (2) Blair Beekman urged open public policy practices, and addressed the Police Chief vacancy and opportunities for reimagining.

Vice Mayor Chappie Jones questioned the City Clerk on how the process can be more transparent. City Clerk Toni J. Taber, indicated that the Brown Act provides 72 hours for agenda *(Item Continued on the Next Page)*

posting and the Sunshine process is posted for the publics' review. She added that she will be offering 'Coffee with the Clerk' to educate the public on how the process works.

Councilmember Raul Peralez offered comments on participatory process and confirmed that Items 4.1 & 4.2 will be heard separately, should be heard in succession and not before 4 p.m.

<u>Action</u>: Upon motion by Councilmember Raul Peralez, seconded by Councilmember Sylvia Arenas, and carried unanimously, the Committee accepted the March 16, 2021 Final Agenda, including a 'time certain' for 4.1 & 4.2 not to be heard before 4 p.m. and to be heard in succession. (5-0.)

2. Review March 23, 2021 Draft Agenda

<u>Public Comment</u>: (1) Martha O'Connell, representing the Mobile Home Association, addressed Item 8.3, requesting a time certain since public waiting too long, which impacts many vulnerable residents. (2) Blair Beekman spoke to the topic of reimagining, urging minimal practices used in the future of policing. He added the concept of rent forgiveness needs to be encouraged during this time of COVID. (3) Paul Soto asked for more clarity to the agendization process and spoke to grant money being used for affordable housing at the expense of those experiencing poverty.

Councilmember David Cohen offered that setting a time certain should wait until next week's ROGC meeting.

<u>Action</u>: Upon motion by Councilmember David Cohen, seconded by Councilmember Dev Davis, and carried unanimously, the Committee accepted the March 23, 2021 Draft Agenda. (5-0.)

<u>Public Comments</u>: (1) Blair Beekman offered that the public should not have to pay back this debt, that COVID is no one's fault. (2) Paul Soto asked that the 'gong' be taken out during public comment and spoke to social upheaval as a result of neglect and apathy, red-lining and social injustice.

<u>Action</u>: Upon motion by Councilmember Dev Davis, seconded by Councilmember Sylvia Arenas, and carried unanimously, the March 15, 2021 Special Meeting Agenda on the City Roadmap - From COVID to Recovery was accepted. (5-0.)

<u>Public Comments</u>: (1) Blair Beekman spoke to financial difficulties, suggesting a subsidy funding program or a tiered system so lower income individuals are not overcharged. (2) Paul Soto feels bearers of this weight will be the Chicano community, and he advocated for relief and spoke against gentrification.

Councilmember David Cohen noted that there may be confusion about the nature of this meeting, clarifying that it is not about water rates.

He noted that SOMOS does good work, but said the City should expand its outreach and spoke favorably of Conxiòn.

Henry Smith, representing the Mayor's Office, addressed Paul Soto's comments and explained why there is sometimes a delay when allowing a speaker onto the platform.
