#### SUBJECT: APPROVAL OF RECOGNIZING WILLOW GLEN HIGH SCHOOL AS THE 2021 SANTA CLARA COUNTY HIGH SCHOOL MOCK TRIAL TOURNAMENT CHAMPIONS SPONSORED BY COUNCIL DISTRICTS 6 AND 9 AS A CITY COUNCIL SPONSORED SPECIAL EVENT TO EXPEND CITY FUNDS AND ACCEPT DONATIONS OF MATERIALS AND SERVICES FOR THE EVENT

#### **RECOMMENDATION**

# BACKGROUND

The Santa Clara County High School Mock Trial Program is sponsored by the Santa Clara County Office of Education, the Santa Clara County Bar Association, and the Santa Clara County Superior Court. It provides a unique opportunity for high school students to acquire a working knowledge of what it is like to prepare for and present a legal case before the court. Teams of 18 students study a hypothetical case that is provided by the Constitutional Rights Foundation (CRF). Each team must be prepared to either defend or prosecute the case, fulfilling the roles of pretrial attorneys, prosecutors, defense attorneys, witnesses, and court staff. These teams conduct legal research and receive individual coaching by their school coach and a volunteer attorney in trial preparation, courtroom protocol, courtroom procedure, analysis and communication.

On February 16, 2021, Willow Glen High School's defense team defeated Cupertino High School's prosecution team in the championship round of the Santa Clara County High School Mock Trial Tournament by a score of 893 to 857. The seven-round, four-week Zoom tournament involving twenty public and private high schools was conducted entirely through Zoom. The tournament was presided over by sitting superior court judges and is scored by hundreds of local attorneys.

Willow Glen's pretrial attorney Maya Carpenter and Sanvi Manik, who portrayed the defendant, were named Willow Glen's MVPs of the final round. The Willow Glen team is coached by local attorneys Jim Scharf and Doug Johns.

Willow Glen High School then advanced to the state championship where they went 2-2, placing 16th out of 34 total teams. However, that record doesn't tell the whole story. Willow Glen won its first two rounds against Contra Costa County and Fresno County. In round three Willow Glen lost a very close round against Ventura County, the team that went on to win the state tournament. In round four, Willow Glen tied Orange County but unfortunately lost the presiding judge's tie-breaker. Willow Glen's only true loss was to the state champion. Willow Glen proved that it was a top tier team at states. No Santa Clara County Team has achieved greater than 2-2 at the state championships in the past eleven years.

Mock Trial is one of the few interscholastic competitive activities that survived the pandemic. We are very proud of each and every student on the Willow Glen High School Mock Trial team for all of the hard work and dedication that attributed to their achievements in both the 2021 Santa Clara County High School Mock Trial tournament and the succeeding state tournament.

#### ANALYSIS

Approval by the City Council of the event will ensure compliance with the Council's prior direction regarding Council Special Events. In observance of existing fundraising disclosure requirements, Councilmember Pam Foley and Councilmember Dev Davis will report any cash or in-kind donations received for the event on their Disclosure of Fundraising Report (DFR-1). Approval of this memorandum will enable Council District 6, Council District 9, City departments and the Office of the City Clerk to proceed with the event. Any cash donations received will be processed pursuant to the City's normal financial and budgetary procedures.
