# 2020-2025 Consolidated Plan Goals

- Increase housing opportunities and self-sufficiency for homeless populations and assist in the prevention of homelessness for at-risk individuals and families.
- Create new affordable housing opportunities and preserve existing affordable housing.
- Promote fair housing and lowered barriers to housing
- Strengthen and stabilize communities' conditions and help to improve residents' opportunities such as the ability to increase their employment prospects and grow their assets.



# **2021-22 Action Plan Highlights**

- ▲ Most investments will continue for an additional year.
- New: WiFi networks in Oak Grove and Independence High School neighborhoods.
- New: Job training contracts with International Rescue Committee and Job Train.
- ▲ Funding for Families: \$10,715,255


